High Uintas Wilderness Domestic Sheep Analysis EIS

IN PROGRESS

This is an evaluation of the effects of continued domestic sheep grazing in the High Uintas Wilderness.

Next step: After consideration of comments submitted on the supplemental draft EIS, we will release the final EIS and draft record of decision (anticipated spring/summer 2024).

Soapstone Calcite Project EA

IN PROGRESS

This project would involve authorizing small-scale hardrock mining operations for decorative calcite near the headwaters of Iron Mine Creek on the Ashley NF. Approximately 1 mile of new access road would need to be constructed, which would cross both the Ashley and the Uinta-Wasatch-Cache NFs.

Next step: We plan to release the draft decision notice (along with the EA and finding of no significant impact) this winter (2024).

IN PROGRESS

We are revising our 1986 Forest Plan to update our management framework for current natural resource conditions.

Ashley National Forest Aspen Restoration Project EA

This was a programmatic evaluation of the **restoration of aspen stands** outside of designated wilderness.

Next step: Implementation (final decision notice signed 10/2/2023)

Forest-wide Prescribed Fire Restoration Project EA

IN PROGRESS

The proposed project would authorize up to 24,000 acres of **fuels reduction treatments** across the Forest each year. Treatment boundaries would be designed to meet objectives and move areas toward desired conditions.

Next step: The 45-day objection period on the draft decision notice closed 11/13/2023. We anticipate completing the objection resolution process in early 2024.

Buckboard Marina Boundary Realignment EA

DEVELOPING PROPOSAL

We are proposing to adjust the boundary of the Buckboard Marina's special use permit to remove water acreage and potentially add areas of land to the south and east.

Next step: We plan to have a 30-day comment period on the EA (anticipated spring 2024).

Dry Creek Trona Mine Project EIS

IN PROGRESS

The BLM is considering a trona mine proposal from Pacific and Atlantic Soda Company. A portion of the proposal involves construction of a water pipeline across the northern end of the Flaming Gorge National Recreation Area.

Next step: We anticipate the draft EIS will be released for comment in early 2024.

DEVELOPING PROPOSAL

We are developing a new management plan for the Flaming Gorge National Recreation Area (NRA). The plan will include direction for all resources and resource uses in the NRA.

Next step: We plan to have a 30-day comment period on the EA in early 2024.

Ashley Karst Timber Stand Improvement CE

COMPLETED

We plan to **thin young lodgepole pine stands** across approximately 7,349 acres in the Ashley Karst National Recreation and Geologic Area.

Next step: Implementation (decision memo signed 10/12/2023)

Anthro Reentry Lop and Scatter CE

IN PROGRESS

We would re-enter approximately 7,820 acres of previously treated shrub communities with a hand crew using chainsaws to remove the encroaching conifer.

Next step: Decision memo anticipated April 2024

Harmston Canyon ATV Trail CE

IN PROGRESS

We would construct a new portion of motorized trail connecting with existing roads open to all-terrain vehicle (ATV) use to create a loop trail along the Elkhorn Loop Road.

Next step: Decision memo anticipated January 2024

Yellowstone ATV Trail CE

IN PROGRESS

We are proposing reconstruction of the Yellowstone ATV Trail connections from 50 inches to 60 inches wide.

South Slope Fuels Reduction Project EA

IN PROGRESS

We are working with the Ute Tribe on a proposed crossboundary **fuels management project** on the south slope of the Uinta Mountains. The project area generally encompasses the zone from Yellowstone Canyon to Uinta Canyon.

Next step: We anticipate the 45-day objection period on the draft decision for the Forest Service portion of the project will end mid-February 2024.
