## **ORDER**

## Occupancy and Use in the Umatilla NF Wilderness Areas

Pursuant to 36 CFR, Sec. 261.50(a) and (b), the following acts are prohibited on the area, roads and road segments described in Exhibit A of this order within the Umatilla National Forest, until further notice.

- 1.) Storing, Leaving, or abandoning equipment, personal property or supplies for more than 72 hours. 36 CFR 261.57(f)
- 2.) Possessing or Using a wagon, cart, or other vehicle 36CFR 261.57(h)
- 3.) Riding, Hitching, Tethering or hobbling a horse or other saddle or pack animal in violation of posted instructions 36CFR 261.58(aa)
- 4.) Entering or being in the wilderness with a group consisting of more than 12 persons or 18 head of pack or saddle stock. 36CFR 261.58(f)
- 5.) Shortcutting a switchback on any trail, 36 CFR 261. 55(e)

EXHIBIT A: Wenaha Tucannon Wilderness Area, North Fork Umatilla Wilderness Area, North Fork John Day Wilderness Area

This Order Supersedes Forest Order # 94-24

Pursuant to 36 CFR, Sec. 261.50(e), the following persons are exempt from this order:

- 1. Persons with a permit specifically authorizing the prohibited act or omission.
- 2. Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
