ORDER NUMBER 316

ROAD CLOSURE

Wallowa-Whitman National Forest La Grande Ranger District

Pursuant to 36 CFR Section 261.50 (b), until further notice, the following acts are prohibited in the La Grande Ranger District, within Wallowa-Whitman National Forest on the Forest development road described in this order.

- Using any motorized vehicle prohibited as stated below on Forest development roads (36 CFR 261.54(a)).
 - A. CLOSED ROAD -- 1843 From M.P. 1.50 (Gate at California Gulch) to end at M.P. 2.60 (Interpretive Park).

 CLOSURE PERIOD -- From 8:00 pm on last day of operating season to 6:00 am, Memorial Day (Observed). Also beginning at 8:00 pm Memorial Day (observed) until 6:00 am the following morning and continuing this daily schedule until last day of operating season.
 - B. CLOSED ROAD -- 1843 From Hwy 30 to end at M.P. 2.60. CLOSURE PERIOD - When snow depth reaches 12" or snow grooming has began. T. 2 S., R. 36 E., Sections 22, 21, 16, Willamette Meridian.

Pursuant to 36 CFR 261.50(e), the following people are exempt from this order:

- 1. Persons with a permit specifically authorizing the otherwise prohibited act.
- 2. Persons operating equipment for the purpose of snow grooming.
- 3. Any Federal, State, or local law enforcement officer, or members of an organized rescue or firefighting force in the performance of emergency official duties, or Oregon Trail Hosts assigned to the Oregon Trail Blue Mountain Crossing, Forest Service maintenance personnel, group tours approved and/or accompanied by the Forest Service.
- 4. Any Bonneville Power Administration officer or contractor in the performance of official duty. This exemption is in effect between I84 and California Gulch.
- 5. Any Northwestern Gas Pipe Line officer or contractor in the performance of official duty. This exemption is in effect between I84 and California Gulch.
- 6. Any Chevron Oil Pipe Line officer or contractor in the performance of official duty. This exemption is in effect between I84 and California Gulch.


Violation of these prohibitions is punishable by a fine of not more than \$5000.00 or imprisonment for not more than six months or both. Title 16 USC Section 551.

This order is for the protection of the National Historic Oregon Trail as well as trails and facilities developed for the Blue Mountain Crossing Inperpretive Park and during the winter season for the protection of snow which has been groomed for cross country sking.

LAW ENFORCEMENT

Law enforcement will be by Wallowa-Whitman N.F. law enforcement personnel, La Grande District personnel, and Oregon Trail hosts while working in the area. District personnel or host will note a description of the vehicle and/or individual, and report this to an authorized law enforcement officer who will issue a Notice of Violation.
