

ORDER NUMBER 258

ROAD CLOSURE NOTICE
Wallowa-Whitman National Forest
Baker Ranger District

Pursuant to 36 CFR Section 261.50 (b), the following act is prohibited within the Wallowa-Whitman National Forest on the Baker Ranger District, on that portion of the Forest development roads described in this order. Beginning 12 noon, Wednesday June 23, 1993 and continuing until further notice.

1. Using any motorized vehicle. (36 CFR 261.54 (a)).

Description of road:

Road Number 7315000, and all tributary roads, from the gate to the end of the road. Location is T.6S., R.37E., sections 33, 34, and 35, and T.7S., R.37E., section 3, Willamette Meridian

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit issued by the Baker District Ranger authorizing the prohibited act.
2. Any federal, state or local law enforcement officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
