- Landing of aircraft, or dropping or picking up any materials, supplies, or person by means of an aircraft, including a helicopter (36 CFR 261.58(y)).
- 5. Going into or being upon any area which is closed for the protection of scientific experiments or investigations, public health or safety (36 CFR 261.53 (d & e)).
