

# UNITED STATES DEPARTMENT OF AGRICULTURE FOREST SERVICE OLYMPIC NATIONAL FOREST OLYMPIA, WASHINGTON

## ORDER NO. 06-09-22-01 Wilderness Occupancy & Use

Pursuant to 16 U.S.C. § 551, and 36 CFR § 261.50 (a) & (b), the following acts are prohibited within the five designated wilderness areas of Olympic National Forest: Buckhorn, Colonel Bob, Mount Skokomish, The Brothers, and Wonder Mountain, as described below and shown in Exhibit A. This Order is effective on \_\_\_\_\_\_\_\_, 2022 and will remain in effect until \_\_\_\_\_\_\_\_, 2024, unless rescinded earlier.

#### PROHIBITIONS:

- 1. Tethering a horse or other saddle or pack animal to trees and/or other vegetation, except for incidental use not to exceed 30 minutes. 36 CFR 261.58(aa).
- 2. Using the area by groups larger than 12 persons and/or 8 head of livestock. 36 CFR 261.58(f).
- 3. Building, maintaining, attending, or using a fire or campfire above 3,500 feet. 36 CFR 261.52(a).
- 4. Storing equipment, personal property, or supplies for a period in excess of 24 hours. 36 CFR 261.57(f).
- 5. Possessing or using a wagon, cart, or other vehicle. 36 CFR 261.57(h).

#### **CLOSURE AREA:**

The Buckhorn, Colonel Bob, Mount Skokomish, The Brothers, and Wonder Mountain Wilderness Areas. See Exhibit A.

#### **EXEMPTIONS:**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

- Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order) specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.


Violations of these prohibitions are punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for a corporation or imprisonment for not more than six months or both. 16 U.S.C. § 551 and 18 U.S.C §§ 3551, 3559, 3571, and 3581.


