## Left Fork Fire Suppression and Restoration Area Road Closure

### A. PROHIBITIONS

Pursuant to 16 U.S.C. 551 and 36 CFR 261.50(a) and (b), the following acts are prohibited in the National Forest System (NFS) lands, roads, and trail within the Powell Ranger District of the Dixie National Forest described in this Order and shown on the attached map incorporated into this Order as Exhibit A ("Closed Area, Roads, and Trail"):

**Going into or being on the Closed Area, Roads, and Trail. 36 CFR 261.52(e), 261.54(e), 261.55(a).**

### B. EXEMPTIONS

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order.

1. Persons with a special use authorization (including grazing) or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

### C. CLOSED AREA, ROADS, AND TRAIL

Closed Area: All NFS lands within the following boundary. Starting at the intersection of Forest Service Road (FSR) 211 (Blubber Creek) and FSR 087 (East Fork Rd), north to the western junction with FSR 106, south to the intersection with FS 1103, continuing south along Forest Service Trail 33066 (Grand View Trail) to the intersection with FSR 105, then north to the intersection of FSR 087, north on FSR 087 to the intersection of FSR 211. Forest Trail 33066 (Grand View Trail) will remain open to non-motorized use.

Closed Roads:

1. NFS Roads 105, 106, 211, 882, 884, 1103, 1190, 1351.

### D. PURPOSE

The purpose of this Order is to protect public safety during the Left Fork Fire suppression and restoration operations.

#### **E. IMPLEMENTATION**


1. This Order is effective on Sunday July 10, 2022, at 11:00 P.M. and shall remain in effect until October 31, 2024, or until modified or rescinded, whichever is sooner.

2. Exhibit A, Map, is attached and incorporated into this Order.

**A violation of these prohibitions is punishable as a class B misdemeanor by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment of not more than 6 months [16 USC 551, 18 USC 3559, 3571, 3581].**

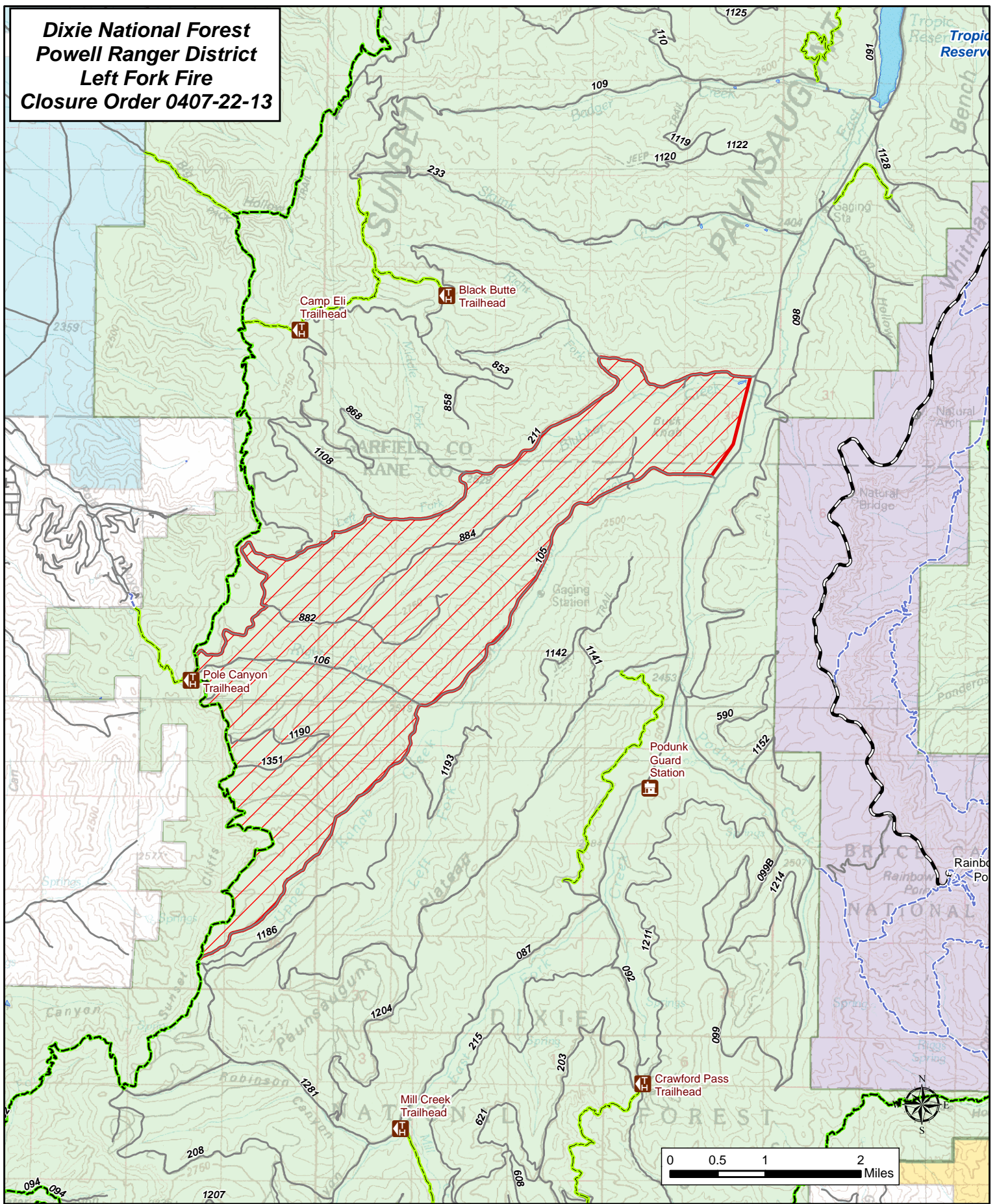
