On 08/25/2022, at 11:00 AM, sealed bids will be opened in the Forest Supervisor's Office, Attn: Timber Mgmt., Room 238D, P.O. Box 1270, Hot Springs, AR 71902 for the Fancy Hill sale. This sale is located in T4S-R26W Sections 18-20, 28-30, and 32-36; T4S-R27W, Sections 13, 14, 23, and 24; Montgomery County Arkansas. T5S-R26W, Sections 2-5, 9-11; Pike County Arkansas.. Timber sale Contract 2400-6T will be used. The termination date for this sale is 11/10/2025. This is a small business set-aside sale.

This sale will be preferentially awarded to a qualified small business concern. In the absence of any bids from a self-certifying qualified small business concern, the sale will be readvertised without restriction on the size of bidders.

There are 6.04 miles (9.72 kilometers) of specified road reconstruction. A specified road construction cost of \$283,024.00 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 11,328.10 CCF. The Forest Service encourages potential bidders to make their own inspection and estimate prior to bid submission.
