According to Fish and Wildlife Service, grizzly bears are harmed when Open Motorized Route Density exceeds 1 mi/sq mi in more than 19% of the Subunit, when Total Motorized Route Density exceeds 2 mi/ sq mi in more than 19% of the Subunit, and when Secure Core is less than 68%. As Mark's maps just showed, Krause Basin (Peters Ridge Subunit) is harming bears. In fact, current percentages for Peters Ridge Subunit is 52% excessive OMRD, 25% excessive TMRD, and only 34% Secure Core.
