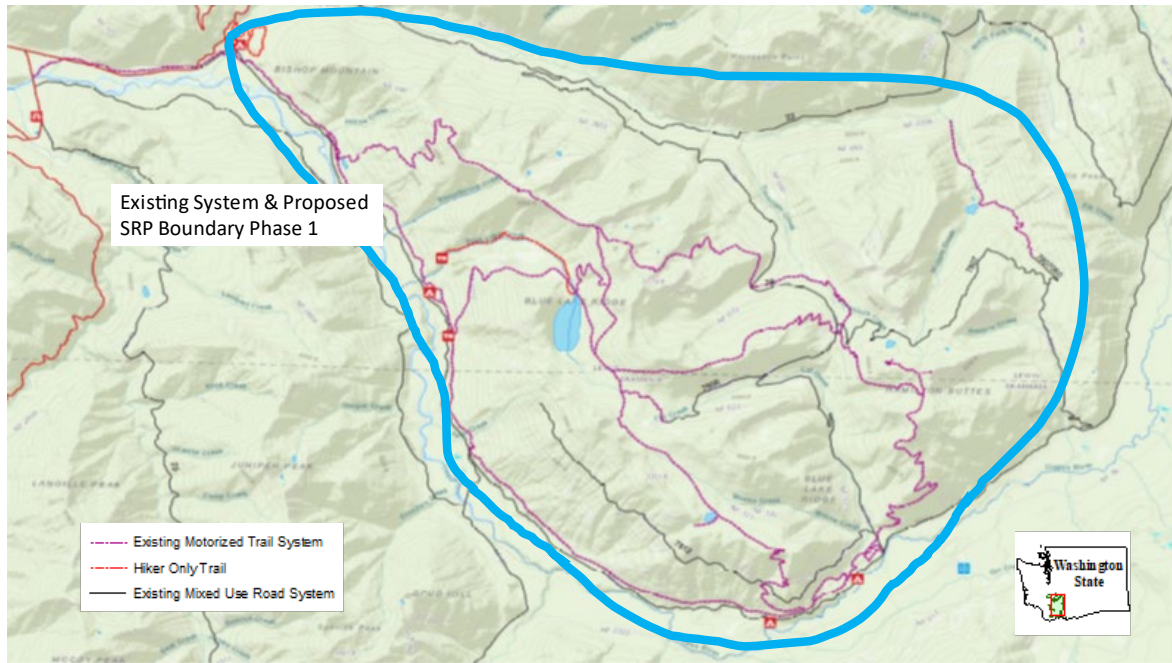


Cat Creek ORV Area – MAP

Phase 2. \$20/two-day pass, \$100 seasonal pass (16 and older)

In Phase 2, the proposal is to create more ATV/UTV access and loop opportunities by expanding the mixed-use road system on the following roads:

- Expand by 6.3 miles to include the entirety of Forest Road 7800000.
- Expand by 5.7 miles to include the western third of Forest 2200000.
- **Expand by 13.7 miles to include Forest Road 5500000.**
- **Expand by 3.3 miles to include Forest Road 5505000.**
- **Expand by 0.9 miles to include Forest Road 5505012.**
- **Expand by 0.4 miles to include Forest Road 5505013.**
- **Expand by 5.3 miles to include a portion of Forest Road 2300000.**
- **Expand by 1.6 miles to include Forest Road 2300083.**
- **Expand by 16.9 miles to include Forest Road 2800000.**
- **Expand by 8.8 miles to include a portion of Forest Road 7700000.**
- **Expand by 8.2 miles to include Forest Road 7605000.**
- **Expand by 3.2 miles to include Forest Road 7600000.**

These roads are currently under analysis in the Yellowjacket Vegetation Management Project on the Cowlitz Valley Ranger District. Phase 2 also proposes increasing the SRP area by approximately 31,000 acres.
