Proposed Changes to Recreation Fees Identified by the Mt. Baker-Snoqualmie National Forest

EVERETT, Wash., *August 18, 2022* — The Mt. Baker-Snoqualmie National Forest is proposing to charge new fees at 20 developed recreation sites, including adding several new day use sites to the popular Northwest Forest Pass program. The full suite of interagency passes will also be honored at these day use sites. The forest will also eliminate fees at two trailheads.

Many day use sites, camping sites, and other recreation sites are currently managed without user fees on the forest. The forest currently waives fees at all Forest Service managed day use sites six days throughout the year.

"National Forests provide recreational opportunities for all Americans. The revenue generated by recreation fees helps protect natural resources and enhance recreation opportunities on our Forests," said Jody Weil, Forest Supervisor for the Mt. Baker-Snoqualmie National Forest. The proposed fees by Ranger District and site are listed below.

*A Northwest Forest Pass or \$5 day use fee is already required at Ranger Creek and Evans Creek campgrounds . The proposed camping fee will replace the current day use fee for the campground.

In 2004, Congress passed the Federal Lands Recreation Enhancement Act (REA) which allows the Forest Service to retain funds collected at certain recreation sites and use these funds locally to operate, maintain, and improve these sites. Ninety-five percent of the revenue from recreation fees remains on the forests to operate, maintain and improve facilities. Raising the revenue collected through recreation fees will help the forests improve infrastructure at campsites and day use sites and hire additional recreation staff during the season of operation. Fees help provide quality recreation opportunities that meet the modern expectations of visitors and creates a more financially sustainable developed recreation program for the benefit of future generations.

Under REA, all new fees and any fee changes must be proposed and approved by a citizens' advisory committee. Committee members represent a broad array of recreation interest groups to help ensure that the Forest Service is proposing reasonable and publicly acceptable new fees and fee changes.

The public is invited to comment on the proposed fee changes to the developed recreation program. The comment period is set to end by close of business on October 21, 2022. Once public involvement is complete, the proposed fee changes will be reviewed by a Recreation Advisory Committee, which will submit its recommendation to the Regional Forester for a final decision.
