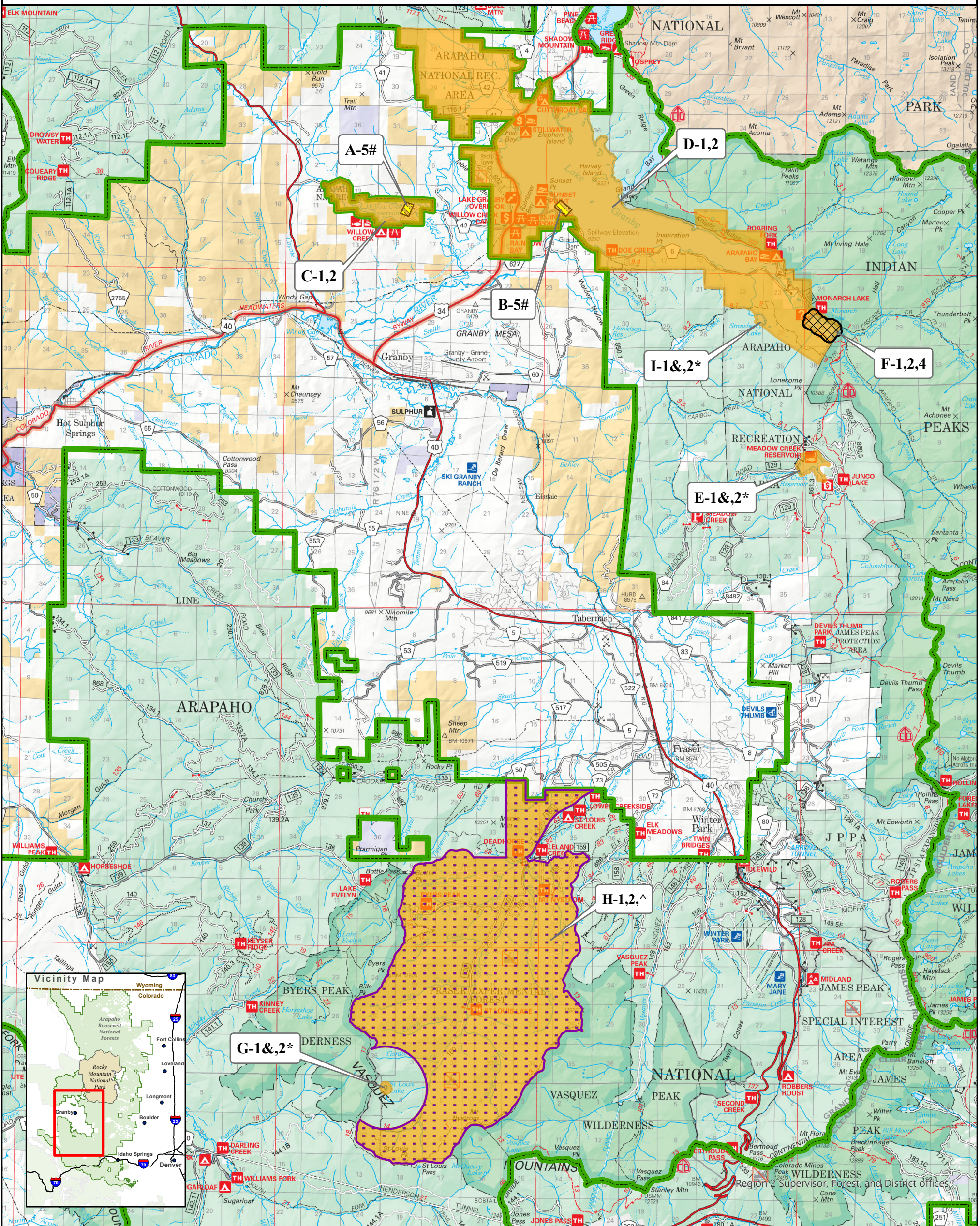

 5. Going into or being on National Forest System lands within the restricted area shown on the exhibit except, vehicles driving through on the roadway. 36 C.F.R. § 261.53(a), 36 C.F.R. § 261.53(e), 36 C.F.R. § 261.53(f)
 - ^ Possessing or using a bicycle off National Forest System roads and trails. 36 CFR 261.56 and 36 CFR 261.55(a)
- * No camping within 100 feet of lake shores.
 & No fires within 100 feet of lake shores.
 # Vehicle traffic allowed on roads but no stopping on roadway or dams.

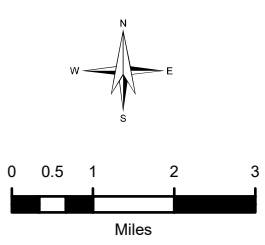
