# Southern Montana RAC Accomplishment Report

The Southern Montana RAC convened 5 times during its term. Members were elected in 2019. The first meeting was an orientation to the RAC in November of 2019. The second meeting in June 2020 led to the awarding of \$469,209 dollars spread across 24 projects. That round of RAC funding was a compilation of multiple years of funding, which was why the available amount was so high. The third meeting held in December 2020 was for the purpose of reviewing proposed fee increases for various recreation fee sites across the east side of the Custer Gallatin. This meeting resulted in the approval of increases at 29 sites (more details below on how these funds have benefitted our programs). The RAC met again in October 2021, approving \$188,645 across 11 projects. Lastly, the RAC's final meeting in December 2022 resulted in the awarding of \$158,105 across 8 projects. In total, The Southern Montana RAC has recommended \$815,959 of Title II funds to project that have benefitted National Forest lands.

## 2020 FEE REVIEW

The RAC Recommended increasing fees at 29 developed recreation sites on the Ashland, Beartooth, Gardiner and Yellowstone Ranger Districts. The recommendations included increasing the fees at 26 sites, implementation of new fees at two campgrounds and adding the Sage Creek cabin as a new rental opportunity. This has resulted in additional revenue, a 95% of which comes directly back to the Custer Gallatin National Forest. These funds have helped improve our recreation programs in some of the following ways:

- Staffing
  - \$217,500 goes into salary for permanent and seasonal employees
  - Money helps fund the conversion of permanent seasonal employees to permanent full time. This gains our programs huge capacity and helps with employee retention.
  - Funds go toward hiring summer MCC interns to perform work at our developed recreation sites
  - Funds go toward funding the necessary vehicles for the program
- Examples of Cabin/Campground Improvements Include:
  - Purchasing firewood supply for cabins (YRD)
  - Painting of outhouses in developed recreation sites (GRD)
  - Bulletin board improvements (Beartooth, GRD)
  - Install new gates (Beartooth)
  - Additional gravel to developed sites (GRD)
  - Toilet pumping and water sampling (All)
  - New firerings (YRD)
  - New chinking at Crandall (YRD)
  - Porcupine repair of windows, door and trim (YRD)

• New mattresses (Ashland, YRD)



## Fees Collected Across the Forest from fee sites:

- 2019: \$316,248
- 2020: \$331,569

Fee Increase Implemented spring 2021

- 2021: \$471,819
- 2022 \$535,143

\* note: numbers are for collections forest-wide and were impacted by variables like covid and 2022 flooding. We also still have one cabin and campground to open with a fee next year, so we anticipate even higher collections in the future.
