## Forest Order # 06-16-00-23-04

## ORDER PHASE A FIRE RESTRICTIONS Wallowa-Whitman NATIONAL FOREST

Pursuant to 36 CFR, Sec. 261.50(a) and (b), the following acts are prohibited on all National Forest System Lands within the boundaries of the Wallowa-Whitman National Forest, in the State of Oregon. This Order is effective from July 14, 2023, 12:01 am, until October 31, 2023, unless rescinded sooner.

## PROHIBITIONS:

- 1. Smoking, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area at least three feet in diameter and cleared of all flammable material. 36 CFR § 261.52(d).
- 2. Operating an Internal Combustion Engine 36 CFR § 261.52(h). (Specifically, Chainsaws between the hours of 1:00 pm and 8:00 pm.)
- 3. Operating or using any internal or external combustion engine without a spark arresting device properly installed, maintained and in effective working order in accordance with U.S. Forest Service Standard 5100-1. 36 CFR § 261.52(j).
- Possess or use a vehicle off National Forest System roads. 36 CFR § 261.56.
  a. Except when parking in an area devoid of vegetation within 10 feet of the roadway.

## EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Any person is exempt from Prohibition 2, operating a chainsaw, when they have a valid personal use firewood cutting permit and follow the conditions outlined in the permit for woodcutting.

Violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both (16 U.S.C. § 551 and 18 U.S.C. §§ 3551, 3559, 3571, and 3581).
