## 14 DAY STAY LIMIT

This order supersedes Order No. 06-14-00-21-06 by Forest Supervisor Eric Watrud, Order No. 06-16-00-21-05 by Acting Forest Supervisor Anthony Botello, and Order No. 06-04-00-21-08 by Forest Supervisor Craig Trulock, set to expire on July 20, 2023.

Pursuant to 16 USC§ 551 and 36 CFR § 261.50(a) and (b), the following act is prohibited within the boundaries of the Umatilla, Wallowa-Whitman, and Malheur National Forests. The order will be effective on July 20, 2023 and will remain in force until July 20, 2026, unless rescinded sooner.

#### PROHIBITION:

Camping on the Umatilla, Wallowa-Whitman, and Malheur National Forests for a period longer than 14 days within any 30-day period. 36 CFR § 261.58(a)

# RESTRICTED AREA:

All National Forest System lands within the Umatilla, Wallowa-Whitman, and Malheur National Forests. (See Exhibit A)

## **EXEMPTIONS:**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order) specifically authorizing the otherwise prohibited act or omission.
- 2. Any Federal, State, or local officer or member of an organized emergency services entity in the performance of an official duty.
- 3. Forest Service employees in the performance of their official duties.

Violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. 16 U.S. C. § 551 and 18 U.S. C. §\$, 3571, and 3581.


