### **OBJECTIVES:**

- Stand up advisory committee:
  - Fulfill FACA requirements: members complete ethics requirements; select Chair; have quorum present; allow time for public comments and distribute written public comments, if requested in advance (no requests or comments received by 6/12/2023 published deadline); post minutes within 90 days of the meeting (by 9/14/2023).
  - Ensure members have shared understanding of the group's purpose, scope, role/authority, and decision processes (from charter); timeframe and nexus with PNT comp plan EA schedule; and ground rules (may come up with these in meeting).
  - o Provide opportunities for introductions, relationship-building, and perspective-taking.
- Consult with the advisory council on the draft comprehensive plan and get any recommendations from the council regarding development/contents of the plan
- Identify the council's collective priorities for topics/issues to address in future meetings.
  - Per the <u>National Trails System Act</u>, the Forest Service is specifically required to consult with the advisory council on (1) comprehensive plan, (2) sign standards, and (3) right-of-way (called "national trail planning corridor" in the draft comprehensive plan).
- Select next meeting date (or range of possible dates).
