## EMERGENCY FIRE CLOSURE – Happy Camp Complex Fires

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Oak Knoll and Scott River Ranger Districts of the Klamath National Forest. This Order is effective from September 2, 2023, at 9 AM, through October 1, 2023.

1. Going into or being upon National Forest System lands within the Lightning Complex Fire Restricted Area (described in Exhibit A) as shown on the attached map, Exhibit B. **36 C.F.R. § 261.52(e).**
2. Being on any National Forest System Road within the Happy Camp Complex Fire Restricted Area (listed in Exhibit A) as shown on the attached map, Exhibit B. **36 C.F.R. § 261.54(e).**
3. Being on any National Forest System Trail within the Happy Camp Complex Fire Restricted Area (listed in Exhibit A) as shown on the attached map, Exhibit B. **36 C.F.R. § 261.55(a).**
4. Entering or using any Developed Recreation Site within the Happy Camp Complex Fire Restricted Area (listed in Exhibit A) as shown on the attached map, Exhibit B. **36 C.F.R. § 261.58(b).**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty.
3. Owners or lessees of land in the area to the extent necessary to access their property.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A. A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

## **EMERGENCY FIRE CLOSURE – Happy Camp Complex Fire Restricted Area – Exhibit A**

The boundary of the Happy Camp Complex Fire Restricted Area begins at the intersection of California 96 and Walker Bridge in Township 46 North, Range 9 West, Section 11 and heads south to the intersection of Siskiyou County 8G004 in Township 46 North, Range 9 West, Section 14 and heads easterly until the intersection with 46N45 in Township 46 North, Range 9 West, Section 9; then proceeds south along 46N45 until the intersection with 45N27 at McKinney Saddle in Township 45 North, Range 9 West, Section 8; then continues along 45N27 until the intersection with South Fork Creek in Township 45 North, Range 10 West, Section 14; then continues south along South Fork Creek until the intersection with the Klamath National Forest Boundary in Township 45 North, Range 10 West, Section 36; then proceeds west along the Forest Boundary until it turns south along the Forest Boundary and continues south until the intersection with Scott River Road in Township 44 North, Range 11 West, Section 25; then follows Scott River Road until the intersection with 46N64 in Township 44 North, Range 11 West, Section 10; then follows 46N64 north until the intersection with 46N65 in Township 45 North, Range 11 West, Section 33; then continues northeasterly along 46N65 until the intersection with 45N05Y in Township 45 North, Range 11 West, Section 26; and proceeds along 45N05Y until it intersects with 45N71; then continues along 45N71 until the intersection with 45N65 in Township 44 North, Range 11 West, Section 9; then proceeds along 45N65 until the intersection with 46N64 in Township 46 North, Range 11 West, Section 30; then proceeds north along 46N64 until the intersection with California 96; then proceeds north along California 96 crossing the Klamath River and continuing north until the intersection with Siskiyou 8D002 in Township 46 North, Range 12 West, Section 11; then continues easterly along 8D002 until the intersection 46N50 Township 46 North, Range 11 West, Section 5; continuing along 46N50 until the intersection with 47N69 at Township 47 North, Range 11 West, Section 35; proceeding north along 47N69 until the intersection with Forest Service 12 Road at Rainey Saddle at Township 47 North, Range 10 West, Section 12; then continues easterly along the 12 Road until it reaches the starting point at the intersection of Siskiyou 96 and Walker Bridge at Township 46 North, Range 9 West, Section 11.
