Per the <u>National Trails System Act</u>, the Forest Service is specifically required to consult with the advisory council on (1) comprehensive plan, (2) sign standards, and (3) right-of-way (called "national trail planning corridor" in draft comprehensive plan).
- Continue discussion regarding topics identified by the Council in the previous meeting:
 - Tribal treaty rights and resources, as well as tribal utilization of areas along the trail
 - Protecting trail corridor and experience
 - Timber and working landscapes
 - Potential nexus with motorized recreation
- Select next meeting date (or range of possible dates).
- Wildlife
- Visitor use management, carrying capacity, permits, and monitoring
- Completing the PNT as a continuous, nonmotorized trail
- Maintaining the trail
