**Still Fire Emergency Closure for Public Health and Safety**

**PROHIBITIONS**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), the following are prohibited on the National Forest System (NFS) lands, roads, and trails in the Mogollon Rim Ranger District, Coconino National Forest, described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Area/Roads/Trails"):

1. Going into or being upon the Described Area. 36 C.F.R § 261.53(e)
2. Using any motor vehicle on the Described Roads. 36 C.F.R. § 261.54(a)
3. Using any motor vehicle on the Described Trails. 36 C.F.R. § 261.55(b)

**EXEMPTIONS**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting resource in the performance of an official duty.

**DESCRIBED AREA/ROADS/TRAILS**

All National Forest System (NFS) roads, lands, and trails, starting from the intersection of AZ State Route (SR) 87 and National Forest System (NFS) Road 751, following the South Side Highway 87 North and East to NFS Road 6067, then South following the

West side of NFS Road 6067 to NFS Road 513A, Then to NFS Road 513 East to NFS Road 513H, then following NFS Road 513 to NFS Road 513B, then following NFS Road 513B to the NFS Road 95, then following NFS Road 95 South to the intersection with NFS Road 751B, then following NFS Road 751B to the intersection with NFS Road 138. Follow NFS Road 138 West to the NFS Road 751 Junction, then follow NFS Road 751 North to SR 87 at the point of beginning.

The AZ Trail will be closed from the intersection of the Fred Haught Trail to SR 87.

Note: NFS Road 95 will remain open for through traffic only and will be open starting at the intersection with NFS Road 751B to the South.

## **PURPOSE**

The purpose of this Order is to provide for the public health and safety due to firefighting operations and fire danger associated with the Still Fire on the Coconino National Forest.

## **IMPLEMENTATION**

1. This Order shall be in effect from September 28, 2023, at 6:00 pm through December 1, 2023, at 6:00pm, unless rescinded.
2. A map identifying the Described Area/Roads/Trails is attached and made part of this Order as Exhibit A For a digital version of this Order and Exhibit A, go to <https://www.fs.usda.gov/alerts/coconino/alerts-notice>.
3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter 11, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter 11, Parts 200-299, their meaning shall be determined by their plain language definitions.
4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§3559, 3571, and 3581.

6. This Order Supersedes any previous orders prohibiting the same or similar acts in or on the same Described Area/Roads/Trails

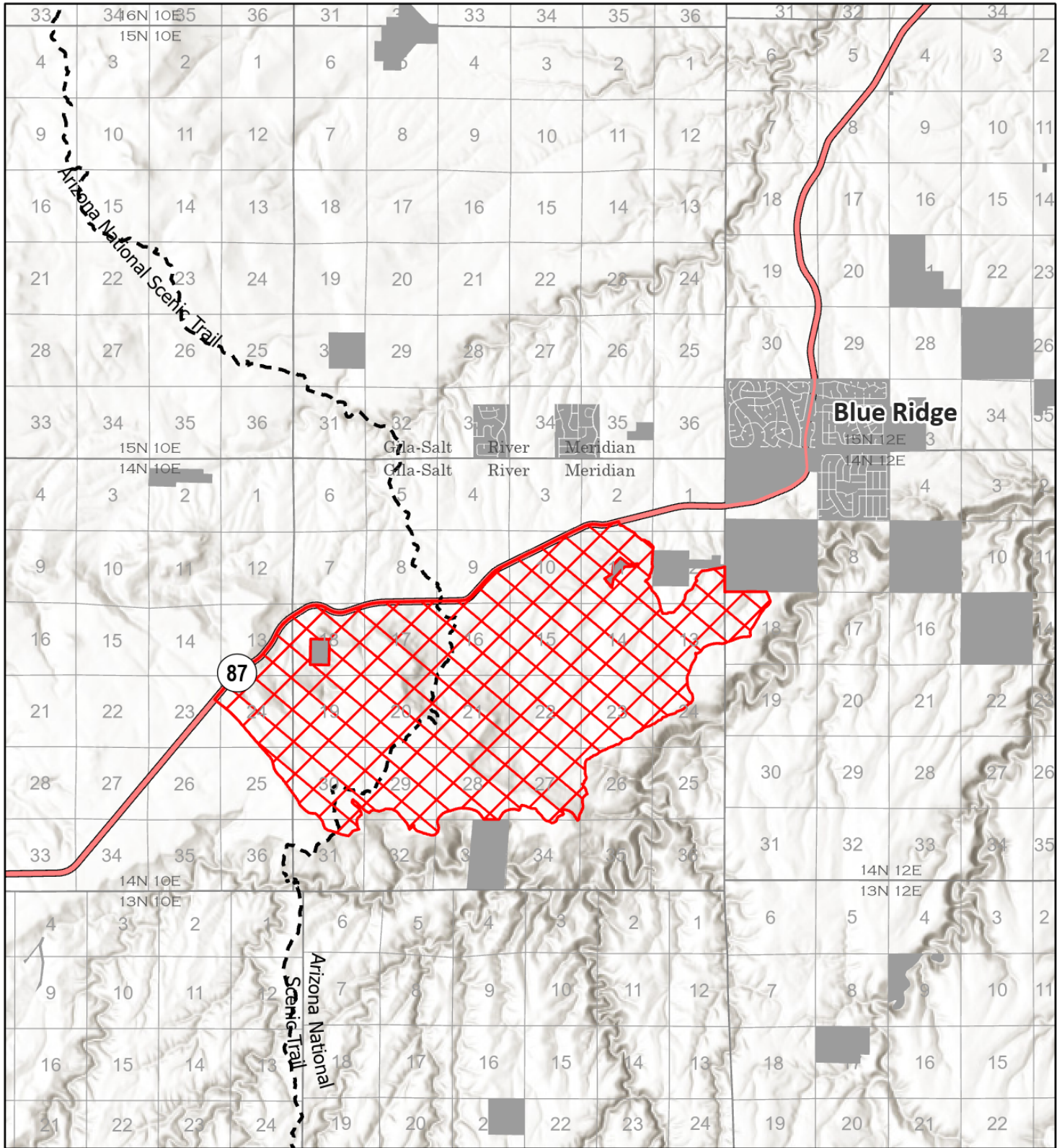

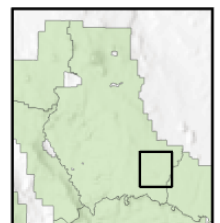
