

Forest Order No. 05-12-55-23-07

Fairview Fire Closure

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the San Jacinto Ranger District of the San Bernardino National Forest. This Order is effective from January 9, 2024, through December 31, 2024.

- 1) Going into or being upon National Forest System lands within the Fairview Fire Closure Area, as shown on Exhibit A and described in Exhibit B. 36 C.F.R. § 261.52(e).
- 2) Being on the following National Forest System Roads:
  - Road 5S15 (Rouse Ridge) from its junction with Road 6S18 to State Hwy 74; and
  - Road 6S22 (Tripp Flat/Cahuilla Mtn), from its junction with Road 6S89 to its junction with Trail 2E43,as shown on the map attached as Exhibit A. 36 C.F.R. § 261.54(e).
- 3) Being on the following National Forest System Trail:
  - Trail # 2E43 (Hixon-Bautista).as shown on the map attached as Exhibit A. 36 C.F.R. § 261.55(a).


Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Any Federal, State, or local officer or member of an organized rescue or fire-fighting force in the performance of an official duty.
2. Persons with a Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.

These prohibitions are in addition to the general prohibitions contained in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

**Exhibit B**

The boundary of the Fairview Fire Closure Area begins at the point of intersection of the south side of State Highway 74 and the western boundary of the San Jacinto Ranger District of the San Bernardino National Forest, to Section 23 T. 6S, R.1E., and continue east along the southern parts of sections 26 & 25 to section 30 T.6S, R.2E and south to the southwestern corner of section 30 and east through sections 29 and 28 to the southeastern corner of section 28, and north through sections 21,16 and 9 to Forest Road 5S15, continues northwesterly along the north side of Forest Road 5S15 to a point of intersection with the south side of State Highway 74 in section 13 T. 5S., R. 1E. to the point of origin.
