Soapstone Calcite Project EA

IN PROGRESS

This project would involve authorizing small-scale hardrock mining operations for decorative calcite near the headwaters of Iron Mine Creek on the Ashley NF. Approximately 1 mile of new access road would need to be constructed, which would cross both the Ashley and the Uinta-Wasatch-Cache NFs.

Next step: The 45-day objection period on the draft decision notice ends 4/15/2024.


Forest-wide Prescribed Fire Restoration Project EA

IN PROGRESS

This project involves implementing up to 24,000 acres of fuels reduction treatments across the Forest each year. Treatment boundaries would be designed to meet objectives and move areas toward desired conditions.

Next step: Address the objection reviewing officer's instructions and conduct an old growth review prior to signing the final decision (anticipated spring/ summer 2024).

East Zone Vault Toilet Replacements CE

COMPLETED

Vault toilet replacements would occur at seven recreation sites on the Flaming Gorge Ranger District and six recreation sites on the Vernal Ranger District.

Next step: Implementation (decision memo signed 3/26/2024)

★ Highway 191 Shaded Fuel Break CE

This project would establish a 760-acre linear fuel break, primarily along Highway 191, mostly on the Vernal Ranger District with a small portion on the northern end occurring on the Flaming Gorge Ranger District.

D1 - Flaming Gorge Ranger District

Buckboard Marina Boundary Realignment EA

DEVELOPING PROPOSAL

We are proposing to adjust the boundary of the Buckboard Marina's special use permit to remove water acreage and potentially add areas of land to the south and east.

Next step: We plan to have public meetings on the proposed action and alternatives (anticipated fall 2024).

> Flaming Gorge NRA Management Plan EA

DEVELOPING PROPOSAL

We are developing a new management plan for the Flaming Gorge NRA. The plan will include direction for all resources and resource uses in the NRA. We would incorporate this area management plan into our 2024 Forest Plan via a programmatic amendment under Title 36 of the Code of Federal Regulations, Part 219.

Next step: We plan to have a 30-day comment period on the EA (anticipated spring 2024).

Dry Creek Trona Mine Project EIS

IN PROGRESS

The BLM is considering a trona mine proposal from Pacific and Atlantic Soda Company. A portion of the proposal involves construction of a water pipeline under Black's Fork in the Flaming Gorge National Recreation Area (NRA) in Wyoming.

Next step: There will be a 45-day comment period on the draft EIS (anticipated June 2024).

★ Lowline Trail New Construction CE

DEVELOPING PROPOSAL

This project would involve approximately 1/2 mile of new non-motorized trail construction to replace a section of the current Lowline Trail.

D2 - Vernal Ranger District

★ Cart Creek Meadow Enhancement Project CE

DEVELOPING PROPOSAL

This project would involve several restoration treatments in a 244-acre project area, including reconstruction of approximately 1/2 mile of the degraded water canal; lopping and scattering of conifer that are expanding into the wet meadow; and seeding and planting.

Next step: CE review form and decision memo (anticipated summer 2024)

★ North Government Park Stream Restoration CE

DEVELOPING PROPOSAL

Restoration treatments would improve a degraded stream and meadow and would include the installation of rock structures and check dams. We would also seed and do a biochar application on approximately 1 acre of upland to combat erosion.

D3/4 - Duchesne-Roosevelt Ranger District

Duchesne-Roosevelt Ranger District CEs

DEVELOPING PROPOSAL

<u>Anthro Reentry Lop and Scatter CE</u>. Removal of conifer encroachment in 7,820 acres of previously treated areas to maintain shrub habitat.

- **Brown Duck Creek Crossing CE**. Relocation of flood debris to restore a safe stream crossing for users of the Lake Fork and Brown Duck Basin trails.
- Dry Ridge Communications Shelter Replacement CE.
 Replacement of an existing shelter at the Dry Ridge communications site to meet design standards.

<u>Harmston Canyon ATV Trail CE</u>. New motorized trail construction to connect existing roads open to all-terrain vehicle (ATV) use along the Elkhorn Loop Road.

- ★ Mill Park Mineral Exploration 2024 CE. Small-scale exploration for valuable minerals near Mill Park.
- Moon Lake Campground Debris Flow Management CE.
 Mitigation of debris flow hazards through construction of a gabion berm and riprapping drainage channel slopes.
- ★ Moon Lake Water System Well CE. Well construction to replace the existing spring water system at the Moon Lake recreation complex.
- ★ West Zone Vault Toilet Replacements CE. Vault toilet replacements at the Yellowstone, Bridge, Rock Creek, Upper Stillwater, Aspen, Avintaquin, and Iron Mine recreation sites, as well as a new toilet installation at the Uinta Guard Station administrative site.

<u>Yellowstone ATV Trail CE</u>. Reconstruction of the Yellowstone ATV Trail connections from 50 inches to 60 inches wide.

Yellowstone Right-of-Way CE. Right-of-way special use permit for an existing access road to private property in Yellowstone Canyon.

South Slope Fuels Reduction Project EA

IN PROGRESS

We are working with the Ute Tribe on a proposed crossboundary **fuels management project** on the south slope of the Uinta Mountains. The project area generally encompasses the zone from Yellowstone Canyon to Uinta Canyon.

Next step: Address the objection reviewing officer's instructions and conduct an old growth review prior to signing the final decision for the Forest Service portion of the project (anticipated spring/summer 2024).

Uinta Basin Railway Project EIS

WITHDRAWN

Withdrawal of the Forest Service decision on this project on 1/17/2024 was in response to an 8/18/2023 ruling by the U.S. Court of Appeals for the District of Columbia Circuit that vacated portions of the Surface Transportation Board's EIS for inadequate environmental analysis. The Forest Service decision would have authorized 12 miles of the proposed railway across National Forest System lands along Highway 191 in Indian Canyon.
