



ORDER NO. 06-02-03-24-01

**AREA, ROAD AND TRAIL CLOSURE
FREMONT - WINEMA NATIONAL FOREST
PAISLEY RANGER DISTRICT**

Pursuant to 16 U.S.C. 551, 36 C.F.R. § 261.50(a) and (b), the following acts are prohibited on National Forest System lands, road, campground, and trailhead within the following described area on the Fremont-Winema National Forest, Paisley Ranger District, as described in the attached Exhibit A. This Order becomes effective on April 18, 2024 and will remain in effect through May 24, 2024, or until rescinded.

PROHIBITIONS:

1. Going onto or being within an area closed for public health and safety. **36 CFR § 261.53(e)**
2. Being on the road. **36 CFR 261.54(e)**

The area described below will be closed to public access/entry due to hazards and hazardous conditions.

AFFECTED AREA/CLOSURE AREA:

National Forest System Road 2800033:

National Forest System Road (NFSR) 2800033 closed at the junction of NFRS 28 within Township 34 South, Range 17 East, Section 32. Closure follows NFSR 2800033 right-of-way to terminus of NFRS FS 2800033 within Township 35 South, Range 16 East, section 1. This closure includes developed recreation sites: Campbell Lake Campground, Campbell Lake Boat Launch, Deadhorse Lake Recreation Site, and Deadhorse Loop Trailhead. See map attached as Exhibit A.

National Forest System Road 3411 (Partial Closure):

National Forest System Road (NFSR) 3411 closed at the junction of NFRS 28 within Township 34 South, Range 17 East, Section 19. Closure follows NFSR 3411 right-of-way to junction of NFSR FS 3372 within Township 34 South, Range 16 East, section 29. This closure includes developed recreation sites: Lee Thomas Campground and Lee Thomas Trailhead. See map attached as Exhibit A.

National Forest System Road 3372 (Partial Closure):

National Forest System Road (NFSR) 3372 closed at the junction of NFRS 3411 within Township 34 South, Range 16 East, Section 29. Closure follows NFSR 3372 right-of-way to junction of NFSR FS 3380 within Township 33 South, Range 15 East, section 25. See map attached as Exhibit A.

National Forest System Road 3380:

National Forest System Road (NFSR) 3380 closed at the junction of NFRS 28 within Township 33 South, Range 15 East, Section 25. Closure follows NFSR 3380 right-of-way to terminus of NFRS FS 3380 at junction of NFSR 3372 within Township 33 South, Range 16 East, section 27. See map attached as Exhibit A.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following are exempt from this Order:

- (1) Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order) specifically authorizing the otherwise prohibited act or omission.
- (2) Any Federal, State, or Local Officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- (3) Owners or lessees of land in the affected area.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Violations of this prohibition are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 551; 18 USC § 3551, 3559, 3571, and 3581)
