Order No. 03-24-03 Eldorado National Forest Developed Recreation Site, Road and Trail Closures

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Amador and Placerville Ranger Districts of the Eldorado National Forest. This Order is effective from April 30, 2024, through December 31, 2024.

- 1. Entering or using the following developed recreation sites, as shown on Exhibit A. 36 C.F.R. § 261.58(b).
 - a. Capps Crossing Campground
 - b. Elkins Flat OHV Staging Area
 - c. Gray Rock Campground
 - d. Martin Meadows Campground
- 2. Being on the following Forest Service System roads, as shown on Exhibit A. 36 C.F.R. § 261.54(e).
 - a. 11N46 from its intersection with 10N44 to its intersection with 10N50 (Also known as Mormon Emigrant Trail)
 - b. 10N57 from its intersection with 10N57B to its intersection with 10N57H (Camp Creek Road)
 - c. 8N05 from its intersection with 8N35 to 8N50 (Panther Creek Road)
- 3. Being on a Forest Service trail within the Elkins Flat OHV Trail System, as listed in Exhibit B. 36 C.F.R. § 261.55(a).
- 4. Being on a Forest Service road within the Elkins Flat Area, as listed in Exhibit C. 36 C.F.R. § 261.5(e).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or Local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571 and 3581.


