**Temporary Area Closure for Unauthorized Livestock Gather
Operations**

PROHIBITIONS

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), the following acts are prohibited on the National Forest System (NFS) lands, roads, and trails in the Alpine Ranger District, Apache-Sitgreaves National Forests, described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Area"):

1. Going into or being upon the Described Area which is closed to protect public health and safety. 36 C.F.R. § 261.53(e).
2. Being upon any road within the Described Area. 36 C.F.R. § 261.54(e).
3. Being upon any trail within the Described Area. 36 C.F.R. § 261.55(a).

EXEMPTIONS

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting resource in the performance of an official duty.

DESCRIBED AREA

The Described Area consists of all NFS lands, roads, and trails within the boundary beginning at the intersection of National Forest System Road (FR) 25 and FR 8750, proceeding south along FR 8750 to its intersection with the East Fork Black River, then proceeding south along the East Fork Black River to its confluence with the Black River, then following the Black River until its intersection with an unnamed ephemeral drainage near Bear Creek, then following the unnamed ephemeral drainage north to its intersection with FR 25H, then following FR 25H until its intersection with FR 555, then following FR 555 west until its intersection with FR 555C, then following FR 555C north to its

intersection with a constructed fence line, then following the constructed fence line north to its intersection with FR 25, then following FR 25 east back to the point of beginning at its intersection with FR 8750.

NOTE: Roads comprising the Described Area boundary remain open for travel.

PURPOSE

The purpose of this Order is to protect public health and safety during operations to gather unauthorized/unbranded livestock in the Described Area.

IMPLEMENTATION

1. This Order shall be in effect from May 14, 2024, at 5:00 pm through June 30, 2024, at 5:00 pm, unless rescinded.
2. A map identifying the Described Area is attached and made part of this Order as Exhibit A. For a digital version of this Order and Exhibit A, go to <https://www.fs.usda.gov/alerts/asnf/alerts-notice>.
3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.

6. This Order supersedes any previous Orders prohibiting the same or similar acts in the same Described Area.
