# **New Canyon Area and Road Closure**

## **PROHIBITIONS**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50 both (a) and (b), the following are prohibited on the National Forest System (NFS) lands and roads in the Sanpete Ranger District, Manti-La Sal National Forest, described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Area and Roads"):

- 1. Being on the restricted road, 36 CFR § 261.54 (e)
- 2. Being in the area, 36 CFR § 261.53(e)

#### **EXEMPTIONS**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
- 2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting resource in the performance of an official duty.

### **DESCRIBED AREA AND ROADS**

<u>The Area</u> inside the following roads: beginning at the junction of New Canyon Road (50039) and Forest Road 50134, thence north to the junction of Forest road 1081, thence east to the junction with Forest Road 50178, thence South the junction with Forest Road 50039 (New Canyon Road), thence south on Forest Road 50114 (Left Hand Fork Road), thence east along Forest Road 50181 (Dusterbergs Road) to the junction with Forest Road 50039 (New Canyon Road).

Forest Road 50039, New Canyon Road, beginning at the Forest Boundary West to the

Junction with Forest Road 50278

<u>Forest Road 50114</u>, Left Hand Fork Road, beginning at the junction with Forest Road 50181 (Dusterbergs), North to the junction with Forest Road 50039(New Canyon Road)

Forest Road 50181, Dusterbergs Road; Forest Road 50134; Forest Road 50182;

Forest Road 50278

#### **PURPOSE**

The purpose of this Order is to provide for public safety during fire operations in the New Canyon Area. Firefighters will be moving along roadways with fire engines to control fire behavior and direction during burn operations.

#### **IMPLEMENTATION**

- 1. This Order shall be in effect from 7 June, 2024 at 0600 through 10 June, 2024 at 0800, unless rescinded.

- 3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
- 4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.
