

## Forest Order No. 05-12-00-24-04 USDA Forest Service San Bernardino National Forest Forest Roads Closure

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), and to provide for public safety and protect natural resources, the following act is prohibited within the San Bernardino National Forest. This Order is effective from **June 3, 2024**, through **May 31, 2025**.

Operating a motor vehicle on the National Forest System Roads within the San Bernardino National Forest as listed in Exhibit A and shown on Exhibits B, C, D and E.

Motor vehicles are defined as any vehicle which is self-propelled, other than (a) a vehicle operated on rails; and (b) any wheelchair or mobility device, including one that is battery-powered, that is designed solely for use by a mobility-impaired person for locomotion and that is suitable for use in an indoor pedestrian area.

36 C.F.R. § 261.54(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- Persons with a Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order;
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty;

These prohibitions are in addition to the general prohibitions contained in 36 C.F.R. Part 261, Subpart A. A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.
