ORDER # 06-12-10-24-06

FOREST ORDER
OCCUPANCY AND USE

Pursuant to 16 USC 551 and 36 CFR 261.50(a) and (b), the following acts are prohibited in the areas described by this order within the administrative boundaries of the Siuslaw National Forest. This order is effective beginning at 12:01 AM on Tuesday, June 25, 2024, and ending at 11:59 PM on Sunday, June 30, 2024.

PROHIBITIONS:

- (1) Using any type of motorized vehicle on roads within the closure area between the hours of 10:30 PM and 6:00 AM local time. **36 CFR § 261.54(a).**
- (2) Using any type of motorized vehicle on designated sand routes within the closure area between the hours of 10:30 PM and 6:00 AM local time. **36 CFR § 261.55(b) and 261.56.**
- (3) Possessing or using a vehicle off National Forest System roads or trails within the closure area between the hours of 10:30 PM and 6:00 AM local time. **36 CFR § 261.56.**

CLOSURE AREA DESCRIPTION:

All areas contained within the Oregon Dunes National Recreation Area west of US Highway 101, south of Tenmile Creek and north of Horsfall Beach Road, located within Township 23S, Range 13W, Sections 13-15, 22-24, 26, 27, 33-35 and Township 24S, Range 13W, Sections 3, 4, 9, 10, 15, 16, 20-22, 27-29, 32-34, as shown in attached map Exhibit A. This closure area is approximately 9,000 acres in size.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

- (1) Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- (2) Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

ORDER # 06-12-10-24-06

Violations of these prohibitions are punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for a corporation or imprisonment for not more than six months or both (16 USC § 551; 18 USC §§ 3551, 3571, 3559, and 3581).















OHV Night Riding Curfew (10:30 PM – 6:00 AM)
