MT HOOD ORDER NO. 06-06-00-23-01

Health and Safety Closure Due to Roadside Danger Trees

Pursuant to 16 USC § 551 and 36 CFR § 261.50 (a) and (b), and to provide for public safety, the following acts are prohibited upon the National Forest System Roads described below and shown in Exhibits A and B. This Order renews Order 06- 06-06-00-22-05, which expired on October 24, 2022. This Order will be effective beginning on June 29, 2023 and ending June 29, 2024.

PROHIBITIONS:

1. Using any type of motor vehicle upon the following NFS Roads as described [36 CFR 261.54(a)]:
 - NFS Road 4300260 from its junction with FSR 43 east to its terminus.
 - NFS Road 3530 at White River Station Campground East to Forest Creek Campground.
 - NFS Road 4800270, 4800271, 4800272, 4800273.
 - NFS Road 4885120, 4885121, 4885122.
 - NFS Road 4885011. 4850029, 4850030, 4850031, 4850032
 - NFS Road 4885.
 - NFS Road 4885130.
 - NFS Road 4885140, 4885141, 4885142, 4885143.
 - NFS Road 4885150, 4885151.
 - NFS Road 4885160.
 - NFS Road 4850 from its junction with 3530 south to the 4850-160 junction.
 - NFS Road 4850140.
 - NFS Road 4850018.
 - NFS Road 4850120 from its junction with 3530 south to the junction of 4850120030.
 - NFS Road 4850122, 4850123.
 - NFS Road 4850121.
 - NFS Road 2120 North from its junction with 2120-330.
 - NFS Road 4500000 (Memaloose Road) from the bridge at highway 224 to the junction with NFS Road 4500310.
 - NFS Road 46200000 starting approximately ¼ mile from the junction of highway 224 (at the green gate).
 - NFS Road 4630000 (Pipeline Road) from the highway 224 junction to the NFS Road 4635000 junction.
 - NFS Road 4600200 (Three Lynx Road) from the highway 224 junction to NFS Road 4630000.
 - NFS Road 4631000 from the highway 224 junction to NFS Road 4630000.
 - NFS Road 5400000 from the highway 224 junction (at the bridge gate) to NFS Road 5410000.
 - NFS Road 5700000 from the highway 224 to NFS Road 5720000.
 - NFS Road 5710000 from the NFS Road 5700000 junction to NFS Road 4640160.

Road closures are depicted in the attached maps (Exhibits A, B, and C).

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.
3. Persons using the road without a motorized vehicle (i.e., on foot, horseback, or non- motorized bicycle).

Violations of this prohibition is punishable as a Class B Misdemeanor, by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 551; and 18USC § 3571).

Violations of this prohibition is punishable as a Class B Misdemeanor, by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 551; 18 USC § 3559 and 18USC § 3571).
