## Greetings Everyone.

In preparing for our upcoming meeting on November 12<sup>th</sup> and 13<sup>th</sup>, I'd like to share with you the attached documents. Please read through them before we meet in person. We want to make the most efficient use of everyone's time and it'll help to all start on the same page.

- The Draft Agenda: This is largely flexible, and we can play much of the meeting by ear. The main goals are to
  move our draft chapters forward, get up to speed on any recent developments, and leave with clear next steps.
   We will begin promptly at 10 am on November 12<sup>th</sup>.
- 2. The Draft Past-Current-Future Conditions Chapter: This chapter provides foundation for draft management principles and recommendations, describing how owl and owl habitat conditions are or are not within the natural range of variation, and where they are projected to head in the future. A next step in this chapter will be to build 'Desired Conditions' from the information within.
- 3. The Draft Management Principles and Recommendations: Remember, these are very much *a draft*, and will benefit from much discussion and further development. We are early in the process and nothing is set in stone. Text in *red italic* is especially called out for discussion and input, particularly from the scientists, but also from the larger group as a whole.
- 4. The Draft Prioritization Principles: This document describes an early effort to envision what a treatment prioritization scheme would look like and will benefit from further discussion

All of these documents are still early drafts, and your input into all of them will be invaluable. Please do not share them beyond this group.
