

ORDER NO. 08-04-01/03-400

UNITED STATES DEPARTMENT OF AGRICULTURE

CHEROKEE NATIONAL FOREST

Developed Recreation Area Restriction

Pursuant to 36 CFR, Section 261.50 (a), it is hereby ordered that the prohibitions hereinafter set forth apply to the developed recreation areas of the Ocoee/Hiwassee District, within the Cherokee National Forest, shown on the attached map.

1. Possessing or operating a motorboat within a designated swimming area or "Boats Keep Out" buoy or sign. **36 CFR 261.58(n)**
2. Water Skiing within a designated swimming area. **36 CFR 261.58(o)**
3. Operating any watercraft in excess of idle speed and creating a wake within posted limits of bathers or boat ramps is prohibited. **36 CFR 261.58(q)**
4. Entering or being in a body of water from ½ hour after sunset until sunrise. **36 CFR 261.58(k)**
5. Hunting within a designated recreation area. **36 CFR 261.58(v)**


The above-prohibited act is set forth in Title 36 C.F.R. Section CFR 261.58.

Pursuant to 36 CFR, Section 261.50 (e), the following persons or areas are exempt from this Order:

1. Persons with a special use permit specifically authorizing the otherwise prohibited act or omission, issued by the District Ranger.

Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
