complete with benches and picnic table, a dog kennel for visiting canines, and new indoor dining table all improve a renter's experience at the cabin.

Recreation Fee Dollars

Recreation fee dollars are an investment in outdoor recreation. They support and enhance:

- Public safety
- Recreation site maintenance and improvements
- Educational experiences
- Informational wayside exhibits
- Youth programs and partnerships
- Interpretive programs

Current and future generations will benefit as 80-95% of the funds are reinvested in the facilities and services that visitors enjoy, use, and value. In addition the Youth **Conservation Corps** help preserve history at the cabin's bunkhouse. The bunkhouse was once a workshop and had black images of tools painted on white walls to ensure that tools were placed in the correct location. Over time those images had been covered, but a historic picture enabled the students to

recreate the look and location of each tool. For a minimal cost, youth had an awesome time re-creating the past.

New Cabin for Rent

Anna Creek Cabin is newly renovated and ready for rental. With no power, no phone and no cell service visitors can enjoy the views and beautiful location without the pressures of today's technology. Anna Creek Cabin, located on the west shore of the Hungry Horse Reservoir, had formally served as a Forest Service work center. It was constructed in 1953 and used up until the 1990s. As all buildings, the lack of use created numerous issues, so the Forest invested \$35,000 of recreation fee revenue to install new counter tops, drywall, flooring, outdoor restroom, parking, pathways, a fire pit and a deck.

Additional Accomplishments:

- Provided snowplowing for winter visitors' access.
- Purchased kitchen supplies for cabins.
- Provided firewood and propane for cabin heat.
- Completed safety inspections at all sites.
- Restored picnic tables at campgrounds.
- Employed river ranger to complete campsite inventories along a Wild and Scenic River.
