METADATA MVUM TRAILS (MVUM_Trails2016)

Summary (Purpose): This GIS dataset contains the trails for which BNF has administrative responsibility and indicates when they are open to motorized use by single-track vehicles (motorcycles) and/or double-track vehicles (ATV's which are 50" or less in width). Trails that do not appear in this dataset are not open to motorized use.

Description (Abstract): The MVUM Trails layer is based on the Bitterroot National Forest Travel Management Plan decision signed in May 2016. The layer will be updated on an annual basis to reflect new travel management designations related to NEPA project decisions. The MVUM Roads layer was created using information populated into the Travel Routes Access and Travel Management (ATM) module. The ATM Module stores the results of forest decisions and management objectives regarding motorized and non-motorized uses of its roads.

Attributes:

ID: Trail number.

NAME: Name of the trail. This information is maintained in the INFRA Trails application.

BMP: Beginning measure point of the route.

EMP: Ending measure point of the route.

SEG_LENGTH: Length of the trail segment, in miles.

SYMBOL: Numeric code which indicates which motorized vehicles are permitted on the trail segment and whether they are permitted yearlong or seasonally.

Value = 9: "Trails Open to Motorcycles Only, Yearlong"

Value = 10: "Trails Open to Motorcycles Only, Seasonal"

Value = 16: "Trails open to wheeled vehicles only < 50 " or less in Width, Yearlong"

Value = 17: "Trails open to wheeled vehicles only < 50 " or less in Width, Seasonal"

SYMBOL_TY: Textual interpretation of the SYMBOL field.

TRAIL_CLASS: Indicates the development stage of the trail, as:

- TC1: MINIMALLY DEVELOPED
- TC2: MODERATELY DEVELOPED
- TC3: DEVELOPED

TRAIL_SYST: NFST - NATIONAL FOREST SYSTEM TRAIL

SEASONAL: Set to "Seasonal " or "Yearlong" to indicate whether the trail is open for motorized use for a portion of the year (seasonally) or yearlong.

ATV: <blank> or "open" to indicate whether the trail is closed or open to wheeled ATV's (i.e., vehicles 50" or less).

ATV_DUR: For trails open to wheeled ATV's 50" or less, this field contains the season (period of the year) when they are **open** to this type of vehicle.

MOTORCYCLE: <blank> or "open" to indicate whether the trail is closed or open to single-track vehicles (i.e., motorcycles).

MOTORCYC_1: For trails open to motorcycles, this field contains the season (period of the year) when they are **open** to this type of vehicle.
