PART 1

FOUNTAIN RANCH PARTNERSHIP of C/O STEVE FOUNTAIN, [REDACTED] [REDACTED] hereinafter called the permittee is hereby authorized to graze livestock owned by the permittee upon designated lands and is administered by the Forest Service within the Colville National Forest.

1. Description of range. The livestock shall be grazed only upon the area described as follows:

It is fully understood and agreed that this permit may be suspended or cancelled, in whole or in part, after written notice, for failure to comply with any of the terms and conditions specified in Parts 1, 2, and 3 hereof, or any of the regulations of the Secretary of Agriculture on which this permit is based, or the instructions of the Forest officers issued thereunder; or for knowledge and willingly making a false statement or representation in the permittees grazing application, and amendments thereto; or for conviction for failure to comply with Federal laws or regulations or State and local laws relating to livestock control and to protection of air, water, soils and vegetation, fish and wildlife, and other environment values when exercising the grazing use authorized by the permit. This permit can also be cancelled, in whole or in part, or otherwise modified, at any time during the term to conform with the needed changes brought about by law, regulation, Executive order, allotment management plans, land management planning, numbers permitted or seasons of use necessary because of resource conditions, or the lands described otherwise being unavailable for grazing. Any suspension or cancellation action may be appealed pursuant to 36 CFR 251, Subpart C.

4. This permit supersedes permit no. 00030B-SUL, issued on 05/18/2001, to FOUNTAIN RANCH PARTNERSHIP

PART 2 - GENERAL TERMS AND CONDITIONS

Validation of Permit. The issuance of a Bill for Collection, payment of fees and actual turning on at least 90 percent of livestock the first grazing season after the permit is issued will validate this permit for the number, kind, and class of livestock, grazing allotment, and period of use for the particular year.

Bill for Collection. Each year, after validation and prior to the beginning of the grazing season, the Forest Service will send the permittee a Bill for Collection specifying for the current year the kind, number, and class of livestock allowed to graze, the period of use, the grazing allotment, and the grazing fees. This bill, when paid, authorizes use for that year and becomes part of this permit.

Payment of Fees. The permittee will not allow owned or controlled livestock to be on Forest Service-administered lands unless the fees specified in the Bill for Collection are paid.

Administrative Offset and Credit Reporting. Pursuant to 31 USC 3716 and CFR Part 3, Subpart B, any monies that are payable or may become payable from the United States, under this permit, to any person or legal entity not an agency or subdivision of a State or local government may be subject to administrative offset for the collection of delinquent debt the person or legal entity owes to the United States. Information on the person's or legal entity's responsibility for a commercial debt or delinquent consumer debt owed the United States shall be disclosed to consumer or credit reporting agencies.

Interest, Penalty, and Administrative Costs. Pursuant to 31 USC 3717 and CFR Part 3, Subpart B, interest shall be charged on any payment or fee amount not paid within 30 days from the date the payment was due. Interest shall be charged using the most current rate prescribed by the United States Department of the Treasury Fiscal Requirements Manual (TFRM-6-8020.20). Interest shall accrue from the date the payment was due. In addition, in the event the account becomes delinquent, administrative costs may be assessed. A penalty of 6 percent per year shall be assessed on any payment or fee amount overdue in excess of 90 days from the date the first billing was due. Payments will be credited on the date received by the designated collection officer or deposit location. If the due date(s) for any of the above payments falls on a non-workday, the charges shall of apply until the close of business on the next workday.

Term of Permit. This permit is effective until 12/31/2020, unless waived, cancelled, or otherwise terminated as provided herein. The permittee has first priority for receipt of a new permit at the end of the term subject to modification deemed necessary by the Forest Service.

In order to update terms and conditions, this permit may be cancelled at any time provided a new permit is issued to the existing permit holder for a new term of 10 years following this update.

Ownership Requirement

a) Only livestock owned by the permittee are authorized to graze under this permit. To exercise use of the permit, the permittee will furnish all evidence of ownership requested by the Forest Service. Livestock purchased and subsequently sold back to the original owner, or to an agent, assignee, or anyone representing or acting in concert with the original owner, within a 24-month period without prior written approval by the Forest officer in charge will not be considered valid ownership of the livestock.

b) Base property owned and used by the permittee to qualify for a term grazing permit must meet minimum base property requirements approved by the officer in charge.

Range and Livestock Management

a) The allotment management plan for the land described on page 1, Part 1 is part of the permit, and the permittee will carry out its provisions, other instructions, or both as issued by the Forest officer in charge for the area under permit and will require employees, agents, and contractors and subcontractors do likewise.

b) The number, kind, and class of livestock, period of use, and grazing allotment specified in the permit may be modified when determined by the Forest Officer in charge to be needed or resource protection. Except in extreme emergencies where resource conditions are being seriously affected by livestock use or other factors, such as fire, drought, or insect damage, notice of a scheduled reduction of numbers of livestock or period of use under a term permit will be given one (1) full year before a modification in permitted numbers or period of use becomes effective. This does not apply to annual adjustment in grazing as provided for in Section 8(c).

c) When, in the judgment of the Forest Officer in charge, the forage is not ready to be grazed at the beginning of the designated grazing season, the permittee, upon request of the Forest Officer, will defer placing livestock on the grazing allotment to avoid damage to the resources. The permittee will remove livestock from Forest Service-administered lands before the expiration of the designated grazing season upon request of the Forest officer when it is apparent that further grazing will damage the resources.

(d) The permittee will allow only the numbers, kind, and class of livestock on the allotment during the period specified in Part 1 hereof or the annual Bill for Collection, including any modifications made as provided for in Section 8(c). If livestock owned by the permittee are found to be grazing on the allotment in greater numbers, or at times or places other than permitted in Part 1 hereof, or specified on the annual Bill for Collection, the permittee shall be billed for excess use at the unauthorized use rate and may face suspension or cancellation of this permit.

(e) The permittee will not allow owned or controlled livestock to be upon any area of Forest Service-administered lands not described in either Part 1 hereof or the annual Bill for Collection.

(f) The Forest officer in charge may, at any time, place or fasten or require the permittee to place or fasten upon livestock covered by this permit appropriate marks or tags that will identify them as livestock permitted to graze on lands administered by the Forest Service. When requested by the Forest officer, the permittee will, at any time during the permitted period of use, including entry and removal dates, gather permitted livestock to enable an accurate count to be made thereof. The Forest Service may, at its option, gather and hold for counting all livestock grazing on the allotment.

(g) Only livestock marked, tagged, or branded as shown in the application upon which this permit is based, and as may be required under Section 8(f), will be allowed to graze under this permit unless the permittee has advance written approval from the Forest officer in charge to do otherwise.

(h) The permittee will pay the costs of, perform, otherwise provide for the proportionate share of cooperative improvements and management practices on the permitted area when determined by the Forest officer in charge that such improvements and practices are essential to proper protection and management of the resources administered by the Forest Service.

(i) This permit is issued and accepted with the provision that the permittee will maintain all range improvements, whether private or Government-owned, that are assigned for maintenance to standards of repair, orderliness, and safety acceptable to the Forest Service. Improvements to be maintained and acceptable to maintenance are specified in Part 3 of this permit. The Government may maintain or otherwise improve said improvements when, in its opinion, such action will be to its advantage.

9. **Nonuse.** At least 90 percent of the livestock permitted must be grazed each year, unless the Forest officer in charge approves nonuse. Failure to place livestock on the allotted range/pasture without approved nonuse may result in cancellation of the term grazing permit in whole or in part.

10. **Protection.** The permittee, or the permittee's agents and employees, when acting within the scope of their employment, and contractors and subcontractors will protect the land and property of the United States and other land under jurisdiction of the Forest Service covered by and used in conjunction with this permit. Protection will include taking all reasonable precautions to prevent, make diligent efforts to suppress, and report promptly all fires on or endangering such land and property. The permittee will pay the United States for any damage to its land or property, including range improvements, resulting from negligence or from violation of the provisions and requirements of this permit or any law or regulation applicable to the National Forest System.

11. General.

(a) The Forest officer in charge may at any time require the permittee to give good and sufficient bond to insure payment for all damage or costs to prevent or mitigate damages sustained by the United States through the permittee's failure to comply with the provisions and requirements of this permit or the regulations of the Secretary on which it is based.

(b) This permit will be cancelled, in whole or in part, whenever the area described in this permit is withdrawn from the National Forest System by land exchange, modification of boundaries, or otherwise, or whenever the area described in this permit is to be devoted to a public purpose that precludes grazing.

(c) The permittee will immediately notify the Forest officer in charge of any change in control of base property, ownership of livestock, or other qualifications to hold this grazing permit.

(d) The permanent improvements constructed or existing for use in conjunction with this permit are the property of the United States Government unless specifically designated otherwise or covered by a cooperative agreement. They will not be removed nor compensated for upon cancellation of this permit, except in the National Forests in the 16 contiguous Western States when cancelled, in whole or in part, to devote land to another public purpose including disposal. In the event of such cancellation on the National Forests in the 16 Contiguous Western States, the permittee will be compensated for the adjusted value of approved range improvements installed or placed by him.

(e) The permittee may not transfer, assign, lease, or sublet this permit in whole or part.

(f) This permit includes the terms and conditions of Part 3 hereof, consisting of page 3 through 7 which follow.

Objective: Maintenance keeps all range structural improvements, as near as possible, at the standard to which they were constructed. It is the responsibility of the permittee to ensure improvement maintenance is done. Failure to perform maintenance at levels described below could result in suspension or cancellation of all or a portion of the permit.

Improvement maintenance will be done during periods of nonuse.

Salt will not be placed closer than ¼ mile from ANY water source without Forest Service approval.

Any hay or straw used in association with this permit, will be certified weed free by the North American Weed Free Forage Program standards or a similar certification process. Noxious weed free feed is required by prevention standard 4 contained in the Pacific Northwest Region Invasive Plants Program EIS and Record of Decision, 2005.

Staples and Nails

Missing staples or nails will be replaced. Staples will be tight against wire on solid posts but must provide for movement of the wire (1-1/2" staples should be used). Loose or replaced staples should be driven to desired depth. Do not kink the wire by driving staples too deep.

Steel Posts

Steel posts will be straightened and, as needed, redriven to a depth that leaves the anchor spade fully covered. Upward pressure will be relieved by the use of a rock suspended from the fence. Wires will be securely fastened to the posts.

Wood Posts

Broken or rotten fence posts or brace posts will be replaced with treated wood posts. Broken braces assemblies will be replaced with treated wood posts or Metal Easyfence panels where and when needed to maintain the fence.

Trees may be used as fence posts only when they are: 1) within 2 feet of the fence alignment; 2) at least 8 inches in diameter 4.5 feet above the ground and; 3) protected from the wire by scabs that are at least 1.5 inches thick, which are attached by spikes nailed into the tree.

Stays

Broken or missing stays will be replaced where needed.

Gates

Solid gate posts which are properly braced are necessary for proper gate function. Stays of a reasonable weight must be secured to the wire gate to prevent the wires from twisting or tangling together when the gate is opened.

Wire

All broken wires will be spliced with #12-1/2 barbed or barbless wire or #10, or larger, galvanized tie wire. Slack wires will be tightened by splicing. Use wire stretchers to tighten wires. Twisted or kinking of wires to take up slack is not permitted.

Corrals

Corrals will be kept clean of litter, in good repair and in usable condition. Damaged gates will be repaired or replaced. Broken or rotten posts, poles and boards will be replaced as needed.

Spring source enclosures devices must be maintained in a high quality state. All wires must be tight and braced corners should be adequate to maintain a tight and effective fence. Enclosures should be maintained so that livestock can not access the enclosed area. Special attention should be given to locations where water channels enter and exit the enclosed area so that livestock can not go under or over the fencing.

Water troughs must be kept level and stable so that water does not spill over the edge of the trough before reaching the height of the overflow. Water inlets and overflows must function as intended to deliver water to the trough and carry excess water away from the trough location in order to keep the water trough location dry. Water troughs need to be accessible by livestock and will need to be filled in around if eroding soil does not allow access to the trough. Poles, posts, and trough framing materials used in the construction of the water development will be maintained, repaired, or replaced as needed.

Pipeline leaks will be repaired or the damaged section replaced with material similar to the original construction material. Water delivery pipelines may be above ground or buried. Above ground pipelines will be protected from livestock with line poles and/or posts. All above ground pipeline support structures will be maintained to keep the pipes at gradient and prevent sagging. Buried pipelines or buried portions of pipelines must have enough cover to protect the pipeline from damage. Headbox lids or covers shall be in place to prevent dirt, rodents, or other refuse from getting into the headbox.

It is fully understood and agreed that this permit may be suspended or cancelled, in whole or in part, after written notice: (a) for failure to comply with the terms and conditions in this permit, regulations of the Secretary of Agriculture on which this permit is based, or annual operating or other instructions of Authorized Officers issued pursuant to this permit; (b) for knowingly and willfully making a false statement or representation in the grazing application on which this permit is based; (c) for conviction for failure to comply with Federal laws or regulations or State and local laws relating to livestock control and to protection of air, water, soil and vegetation, fish and wildlife, and other environmental values when exercising the grazing use authorized by the permit; or (d) because the lands described in #1 above are no longer available for grazing. This permit can be modified to conform to current situations brought about by changes in law, regulation, executive order, allotment management plans, or land management planning. This permit may also be modified because of resource conditions. The permit will be cancelled if the permittee loses control of the land offered as the basis for the permit. Any decision to suspend or cancel this permit, in whole or in part, may be appealed by the permittee pursuant to 36 CFR 251, Subpart C.

5. This permit supersedes Permit # 00030C-SUL issued on June 4, 2001.

PART 2 - GENERAL TERMS AND CONDITIONS

1. Term of Permit

(a) This permit expires on 12/31/2020, unless cancelled, or otherwise terminated on an earlier date as provided herein. The permittee has first priority for receipt of a new permit at the end of the term provided the permittee has fully complied with the terms and conditions of the expiring permit. The terms and conditions in a new permit may be different from those of the expiring permit as deemed necessary by the Authorized Officer.

(b) This permit can be issued for ten years on the basis of a lease as long as the permittee annually provides proof that the lease (if for less than ten years) has been renewed. Failure to provide the notification will result in cancellation of this permit.

2. Range and Livestock Management.

(a) Current allotment management plan(s) for the land described in Part 1 is made part of and incorporated into this permit, and the permittee will carry out its provisions, and annual operating or other instructions issued by the Authorized Officer.

(b) This permit may be modified to improve or protect National Forest System lands and resources. Except in emergencies such as fire, drought, or insect damage, modifications in the numbers of livestock or seasons of use in the permit should not occur until one year written notice of the modification has been provided to the permittee. This does not apply to annual adjustment in grazing as provided for in Section 2(c).

(c) The Authorized Officer may require the permittee to defer placing permitted livestock on the land described in Part 1 of the permit at the beginning of the period of use if the forage is not ready to be grazed. The Authorized Officer may also require the permittee to remove permitted livestock from the lands described in Part 1 of the permit before the expiration of the period of use if the available forage has been consumed, standards are not being met, or to prevent damage to National Forest System lands and resources, and/or other lands under Forest Service control.

(d) The permittee will allow only the numbers, kind, and class of livestock on the allotment during the period of use specified in Part 1 of the permit, annual operating instructions, or the Bill for Collection, including any modifications made pursuant to Section 2(b), or annual adjustments to grazing pursuant to Section 2(c). If the permittee's livestock are grazing in greater numbers, or at times or places other than authorized by this permit, the permittee shall be billed for excess use at the unauthorized use rate and the Authorized Officer may suspend or cancel this permit.

(e) The permittee's owned or controlled livestock may not be on National Forest System lands or other lands under Forest Service control except as authorized by this permit or the Bill for Collection.

(f) The Authorized Officer may require the permittee to place or fasten appropriate marks or tags on their livestock that will identify them as permitted to graze under this permit. The Authorized Officer may require the permittee to gather permitted livestock to enable the Forest Service to conduct an accurate count of the livestock.

(g) Only livestock marked, tagged, or branded as shown in the application upon which this permit is based or as

required under Section 2 (f) will be allowed to graze under this permit.

(h) The permittee will pay the costs of, perform, or otherwise provide for the proportionate share of cooperative range improvements and management practices (which may include identified monitoring related to the livestock grazing use authorized by this permit,) on the land described in Part 1 of the permit when the Authorized Officer determines that such improvements and practices are necessary for the protection and management of National Forest System lands and resources.

(i) The permittee is responsible for the maintenance of all assigned range improvements to standards of repair, orderliness, and safety acceptable to the Authorized Officer and/or as specified in Part 3 of this permit.

(j) The Forest Service is authorized to enter the permittee's privately owned or controlled lands identified in the term private land grazing permit application as the basis for the issuance of this permit to ensure that the livestock grazing occurring thereon is being conducted in accordance with the terms and conditions of this permit.

3. **Protection.** The permittee will protect the lands described in Part 1 of this permit from fire or other damage. The permittee will pay the United States for damage to National Forest System lands and resources, including range improvements, caused by the permittee's negligence or by the permittee's violation of the terms and conditions of this permit or applicable law or regulation.

4. General.

(a) This permit will be cancelled in whole whenever the nonfederal lands identified in Part 1 of the permit are no longer under the ownership or control of the permittee or upon permittee request.

(b) The permittee will notify the Authorized Officer in writing within thirty days of any change(s) affecting the permittee's qualifications to hold this grazing permit. The permittee shall also be required to amend the private land term grazing permit application to reflect this new information.

(c) The permanent structural range improvements on the lands described in Part 1 of this permit are the property of the United States Government unless specifically designated otherwise. Structural range improvements which are the property of the United States may not be removed by the permittee nor may the permittee be compensated for them unless the permit is cancelled in whole or in part in order to devote the lands covered by the permit to another public purpose including disposal. When permits are cancelled to devote lands to another public purpose, permittees may be entitled to reasonable compensation for the adjusted value of their interest in authorized permanent improvements placed or constructed on lands identified in Part 1 of this permit, such compensation not to exceed the appraised fair market value of the terminated portion of their interest in such improvements.

(d) The permittee may not sell, transfer, assign, lease, sublet, or otherwise convey this permit in whole or in part.

(e) The term "permittee" in this permit includes any agents, employees, contractors, and subcontractors who have been hired by the permittee to perform duties associated with and required by this permit.

(f) This permit includes the terms and conditions of Part 3 hereof, consisting of page 3 through 5 which follow.

Noxious weed free feed is required by prevention standard 4 contained in the Pacific Northwest Region Invasive Plants Program EIS and Record of Decision, 2005.

All limbs and trees which have fallen on fences will be cut and removed at least yearly and the wires stretched tight again after removal of the tree.

Staples and Nails

Missing staples or nails will be replaced. Staples will be tight against wire on solid posts but must provide for movement of the wire (1-1/2" staples should be used). Loose or replaced staples should be driven to desired depth. Do not kink the wire by driving staples too deep.

Steel Posts

Steel posts will be straightened an, as needed, redriven to a depth that leaves the anchor spade fully covered. Upward pressure will be relieved by the use of a rock suspended from the fence. Wires will be securely fastened to the posts.

Wood Posts

Broken or rotten fence posts or brace posts will be replaced with treated wood posts. Broken brace assemblies will be replaced with treated wood posts or metal Easyfence panels where and when needed to maintain the fence.

Trees may be used as fence posts only when they are: 1) within 2 feet of the fence alignment; 2) at least 8 inches in diameter 4.5 feet above the ground and; 3) protected from the wire by scabs that are at least 1.5 inches thick, which are attached by spikes and nailed into the tree.

Stays

Broken or missing stays will be replaced where needed.

Gates

Solid gate posts which are properly braced are necessary for proper gate function. Stays of a reasonable weight must be secured to the wire gate to prevent the wires from twisting or tangling together when the gate is opened.

Wire

All broken wires will be spliced with #12-1/2 barbed or bargless wire, or #10 or larger galvanized tie wire. Slack wires will be tightened by splicing. Use wire stretchers to tighten wires. Twisting or kinking of wires to take up slack is not permitted.

Corrals

Corrals will be kept clean of litter, in good repair and in useable condition. Damaged gates will be repaired or replaced. Broken or rotten posts, poles, and boards will be replaced as needed.

Water troughs must be kept level and stable so that water does not spill over the edge of the trough before reaching the height of the overflow. Water inlets or overflows must function as intended to deliver water to the trough and carry excess water away from the trough location in order to keep the water trough location dry. Water troughs need to be accessible by livestock and will need to be filled in around if eroding soil does not allow access to the trough. Poles, posts, and trough framing materials used in the construction of the water development will be maintained, repaired, or replaced as needed.

Pipeline leaks will be repaired or the damaged section replaced with material similar to the original construction material. Water delivery pipelines may be above ground or buried. Above ground pipelines will be protected from livestock with line poles and/or posts. All above ground pipeline support structures will be maintained to keep the pipes at gradient and prevent sagging. Buried pipelines or buried portions of pipelines must have enough cover to protect the pipeline from damage. Headbox lids or covers shall be in place to prevent dirt, rodents, or other refuse from getting into the headbox.
