ORDER # 06-18-01-18-05

FOREST ORDER
OCCUPANCY AND USE

Pursuant to 16 USC 551 and 36CFR 261.50 (a) and (b), and to provide for public safety, the following acts are prohibited in the areas described in this order within the administrative boundaries of the Willamette National Forest. This Order is effective on December 1, 2017 and shall be in effect until rescinded or July 1, 2018.

PROHIBITIONS:

1. Entering into or being upon National Forest System lands closed for the protection of public health or safety. **36 CFR § 261.53(e)**
2. Being on the road. **36 CFR § 261.54(e)**
3. Being on a trail. **36 CFR § 261.55(a)**
4. Entering or using a developed recreation site or portion thereof. **36 CFR § 261.58(b)**

HORSE CREEK COMPLEX CLOSURE AREA DESCRIPTION:

All areas affected by this closure are located within Lane County, Oregon. In Township 15S, Range 7 ½E, Sections 35, 36. In Township 15S, Range 8E, Sections 19-21, 28-33. In Township 16S, Range 6E, Section 36. In Township 16S, Range 7E, Sections 12-14, 23-26. In Township 16S, Range 7 ½ E, Sections 3-5, 7-10, 15-22, 27-30. In Township 16S, Range 8E, Sections 3, 4, 7-10, 15-22, 27-30. In Township 16S, Range 8 ½E, Sections 4-9, 16-21, 28-33. Township 17S, Range 5E, Sections 8-17, 20-29, 33-36. In Township 17S, Range 6E, Sections 1, 7, 8, 12, 13, 17-20, 24-36. In Township 17S, Range 6 ½E, 1-4, 9-16, 21-28, 33-36. In Township 17S, Range 7E, 1-36. In Township 17S, Range 8E, Sections 4-9, 16-21, 28-32. In Township 18S, Range 5E, Sections 1-3, 11-14, 23-26, 36. In Township 18S, Range 6E, Sections 1-35. In Township 18S, Range 6 ½E, 1-4, 9-16, 21-28. In Township 18S, Range 7E, Sections 1-24, 30.

The closure includes all US Forest Service lands, roads and trails within the boundary described below and as depicted on the attached map and incorporated into this order as "Attachment A".

Beginning at Cougar Crossing at the junction of Forest Service Road (FSR) 19 and FSR 500 in the southwest corner of section 28, Township 17S Range 5E. South along the west side of FSR 19, all lands east of FSR 19 and including FSR 19, to the junction of FSR 19 and FSR 441 in Section 33, Township 18S, Range 6E. Continuing east along FSR 441, all lands north of FSR 441 but not including FSR 441, to the Olallie South Trailhead and the beginning of Trail #3529 in Section 34, Township 18S, Range 6E. Continuing north along Trail # 3529, all lands west of Trail # 3529 but not including Trail #3529, to the junction with Trail # 3331. Continuing east along Trail # 3331, all lands north of Trail # 3331 but not including Trail # 3331, to the junction with Trail #

3538. Continuing north along Trail # 3538, all lands west of Trail # 3538 but not including Trail # 3538, to the junction with Trail # 3530. Continuing east on Trail # 3530, all lands north of Trail # 3530 but not including Trail # 3530, to the junction with Trail # 3515. Continuing north along Trail # 3515, all lands west of Trail # 3515 but not including Trail #3515, to the junction with Trail # 3516. Continuing east on Trail # 3516, all lands north of Trail # 3516 but not including Trail # 3616, to its intersection with the Willamette National Forest Boundary (forest boundary) in Section 19, T18S, R8E. Continuing north along the forest boundary, all lands west of the forest boundary, to State Highway 242 at McKenzie Pass. Continuing west along State Highway 242, all lands south of State Highway 242, to where the wilderness boundary leaves Hwy 242 on the section line between Sections 22 and 23 in Township 16S, R 7E. Continuing south and west along the wilderness boundary, all lands east and south of the wilderness boundary, to the southwest corner of Section 28, Township 17S Range 5E. Directly west for 1,417 feet from the wilderness boundary to the intersection of FSR 19 and FSR 500.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50 (e), the following persons are exempt from this Order:

- (1) Any person with a permit specifically authorizing the otherwise prohibited act or omission;
- (2) Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- (3) Owners or lessees of land in the area.

These restrictions are implemented for the safety of the public, and fire suppression personnel.

This order supersedes Forest Order # 06-18-01-18-01, executed October 3rd, 2017.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.
