## EMERGENCY ORDER for SPECIAL CLOSURE Turnagain Pass Snowmachine Area Closure

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on the Seward and Glacier Ranger Districts of the Chugach National Forest. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and becomes effective November 21, 2018 and will remain in effect until April 1, 2018 unless rescinded earlier.

### Prohibited Acts:

36 CFR261 .53 - Special Closures  
36 CFR 261.53 (f) – Property

Due to inadequate snow conditions and to prevent resource damage, operating or possessing a snowmachine in the Turnagain Pass area as described in Attachment A is prohibited.

### Exceptions:

Pursuant to Title 36 CFR 261.50 (e) the following are exempt from this order:

1. Any person with a permit authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

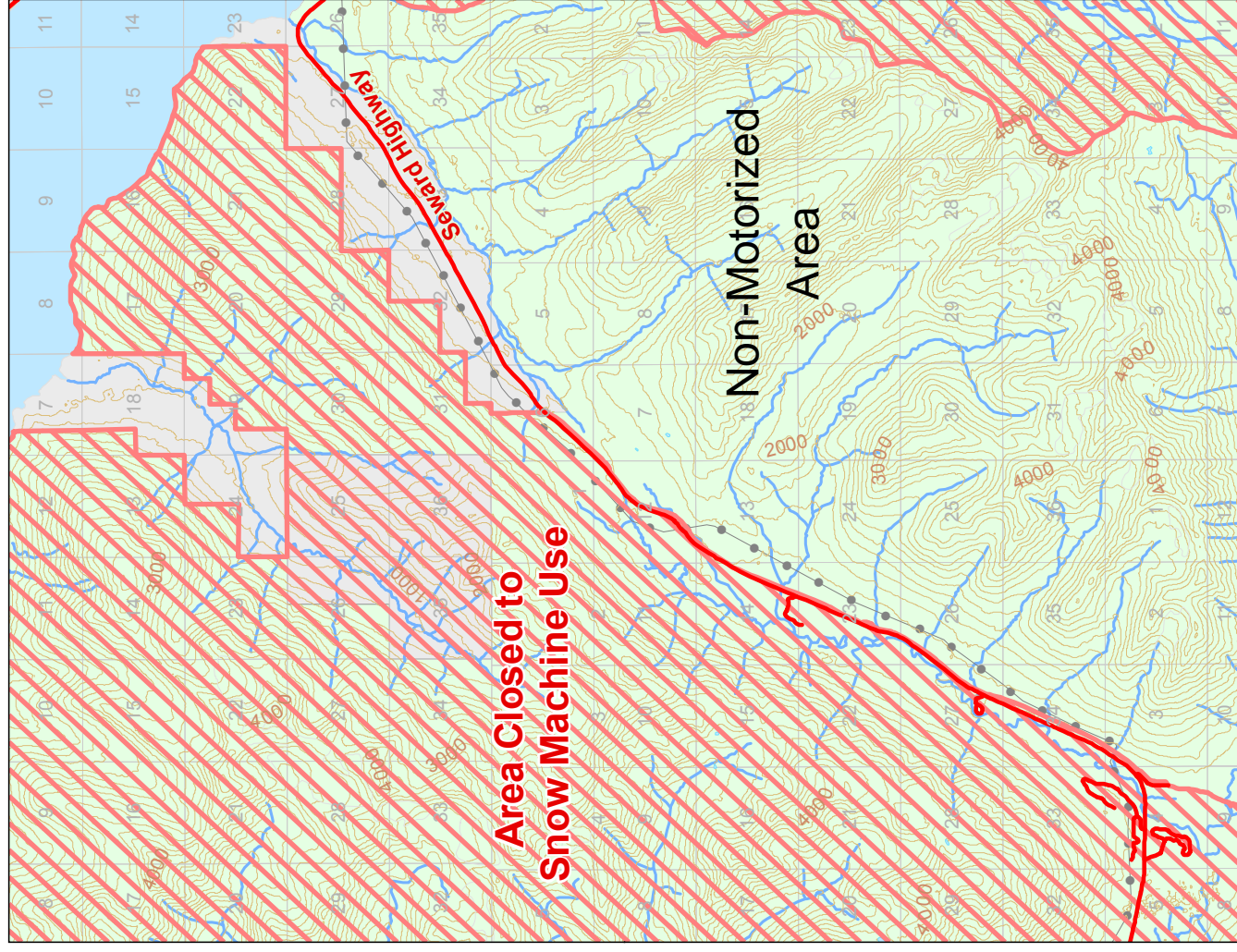
### Penalty:

A copy of this order shall be posted as prescribed under 36 CFR 261.51

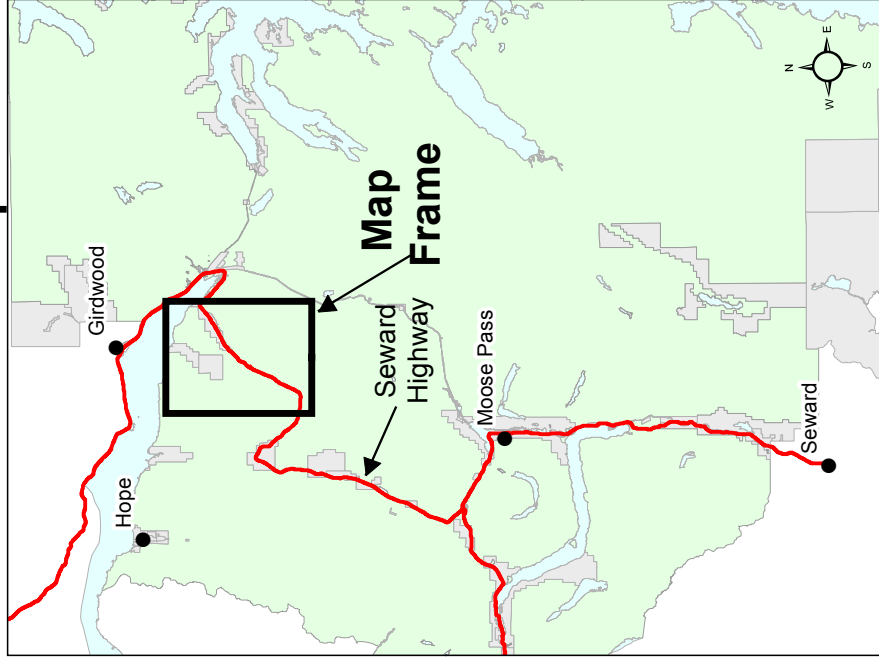
