FOREST ORDER

USDA FOREST SERVICE MEDICINE BOW-ROUTT NATIONAL FORESTS, LARAMIE RANGER DISTRICT NATIONAL FOREST SYSTEM ROAD and AREA RESTRICTION Temporary Road and Area Closure: NFSR 539

Pursuant to 16 (United States Code (U.S.C.) § 551 and 36 Code of Federal Regulations (C.F.R.) § 261.50 (a) and (b), the following acts are prohibited on the described National Forest System Road (NFSR) located in the Fennec Fox Salvage Timber Sale on the Laramie Ranger District of the Medicine Bow-Routt National Forests in Albany County, State of Wyoming, called **NFSR 539** (the "Restricted Road").

The Restricted Road are defined as National Forest System Road:

NFSR 539 including all of the road between the intersections at NFSR 539 south to the road terminus at Wyoming Highway 230.

The Restricted Roads are shown on the attached map hereby incorporated into this Order as Exhibit A.

This prohibition applies to wheeled motor vehicles and other forms of motorized and non-motorized travel, including travel over snow on the Restricted Road, its right-of-way, in non-forested areas adjacent to the Restricted Road. This Order is necessary to provide for public health and safety during the felling and/or removal of trees; when log processing, loading or hauling make travel on the Restricted Road unsafe, and/or when effective closure of the Restricted Road for public safety requires concurrent closure of connecting travel ways, and to prevent resource damage to NFSR road system.

PROIDBITIONS:

Being on the Restricted Road. 36 C.F.R. § 261.54 (e).

EXEMPTIONS:

Pursuant to 36 C.F.R § 261.50(e), the following persons are exempt from this order:

- (1) Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- (2) Resident owners and lessees of land and holders of Forest Service recreational use authorizations, within the Restricted Area or within areas served by the Restricted Roads;
- (3) Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of official duty.

This Order will be in effect when signed and shall remain in in effect until rescinded. Done at Laramie, WY, this 14hday of February, 2019.

MEDICINE BOW-ROUTT NATIONAL FORESTS & THUNDER BASIN NATIONAL GRASSLANDS

Violation of this prohibition are punishable as a Class B misdemeanor by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. $(16 \text{ U.S.C.} \S 551 \text{ and } 18 \text{ U.S.C.} \S 3559 \text{ and } 3571)$.
