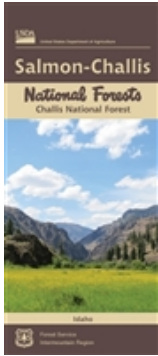
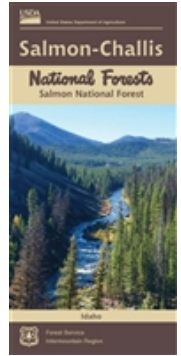


Maps of the Salmon-Challis National Forest



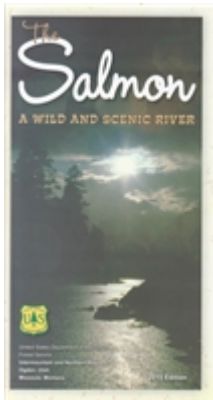
There are two maps needed to cover the Salmon-Challis National Forest; one for the Challis National Forest and one for the Salmon National Forest.



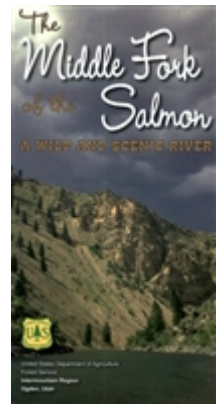
There are two maps for the Frank Church – River of No Return Wilderness; a South



half and a North half (both from 1984).



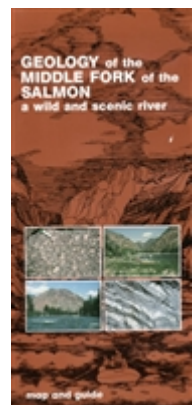
