# **Emergency Area Closure due to Wildfire**

#### **Temporary Special Closure Order**

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on the Chugach National Forest as described below. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations. This order will be in effect from July 8, 2019 and will be terminated when fire danger conditions allow.

#### **Prohibited Acts:**

36 CFR 261.53 (e) - Special Closure

Pursuant to Title 36 Code of Federal Regulations 261.53 (e), due to the concern for public health and safety, it is prohibited to go into or be upon the areas of National Forest System (NFS) lands described as:

 All NFS lands west of Resurrection Pass Trail from the Resurrection Creek Gold Panning Area to Devils Pass Trail and all NFS lands south of Devil's Pass Trail west of the Seward Highway and north of the Sterling Highway. This includes: West Swan Lake, Swan Lake, Romig, Juneau Lake, and Trout Lake cabins.

Except: Caribou Creek, Fox Creek, East Creek and Devil's Pass cabins, Gull Rock Trail, Resurrection Creek Gold Panning Area and Porcupine Campground.

This special closure is in effect for the Seward Ranger District of the Chugach National Forest areas as described and is additionally displayed on Exhibit A.

#### **Exceptions:**

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

- 1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- 2. Any Federal, State or Local Law Enforcement Officer or member of an organized rescue or fire fighting force in the performance of an official duty.
