Emergency Area Closure due to Wildfire

Temporary Special Closure Order

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on the Chugach National Forest as described below. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations. **This order will be in effect from August 18, 2019 and will be terminated when fire danger conditions allow.**

Prohibited Acts:

36 CFR 261.53 (e) – Special Closure

Pursuant to Title 36 Code of Federal Regulations 261.53 (e), due to the concern for public health and safety, it is prohibited to go into or be upon the areas of National Forest System (NFS) lands described as:

- **Russian Lakes Trail is closed from the trailhead at Russian River Camp Ground (Sterling Highway mile marker 52.6) south to Barber Cabin. Closures include Russian River Falls Viewing Platform, Russian River Camp Ground, Barber Cabin, and K’Beq Day Use Area.**

This special closure is in effect for the Seward Ranger District of the Chugach National Forest areas as described and is additionally displayed on Exhibit A.

Exceptions:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State or Local Law Enforcement Officer or member of an organized rescue or fire fighting force in the performance of an official duty.

Penalty:

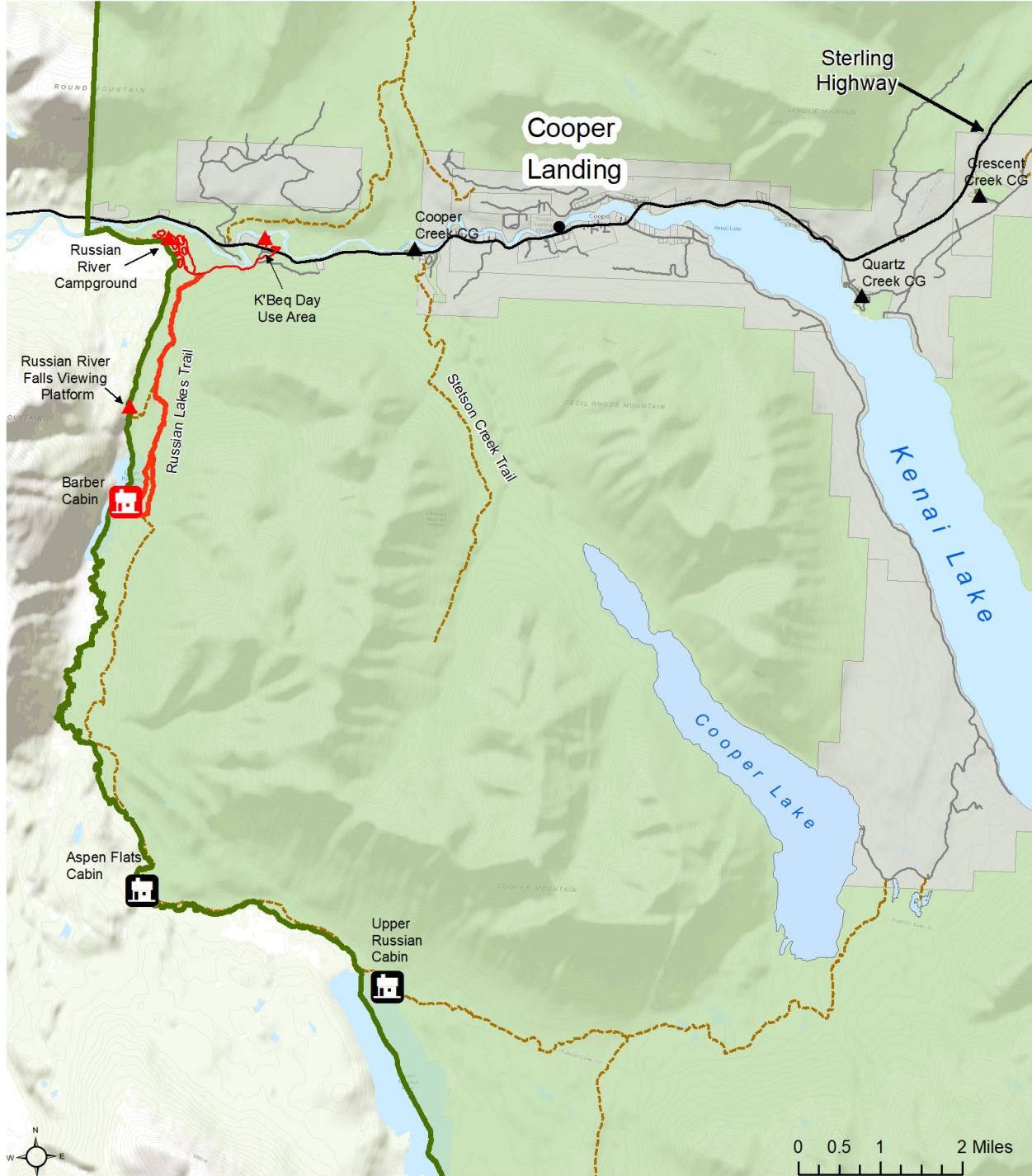
