Alcoholic Beverages Restriction

Pursuant to 36 CFR 261.50 (a) and (b), the following acts are prohibited in the following areas on the Grandfather Ranger District of the Pisgah National Forest. This closure order is effective from January 9, 2020 to January 9, 2025 or until rescinded or superseded by an authorized Forest Service official.

Possessing a beverage which is defined as an alcoholic beverage by state law. 36 CFR 261.58(BB).

This order is for the following areas of the Grandfather Ranger District:


Wiseman's View Overlook, parking lot and Overlook Trail

Curtis Creek Recreation Area, specifically Forest System Road 482 and 1000 feet from either side of the roadway, within the recreation area

Pursuant to the provisions of Title 36 C.F.R, Section 261.50 (e), the following persons are exempt from the above prohibition:

1. Persons with a permit specially authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or Local officer or member of any organized rescue or firefighting force in the official performance of their duties.

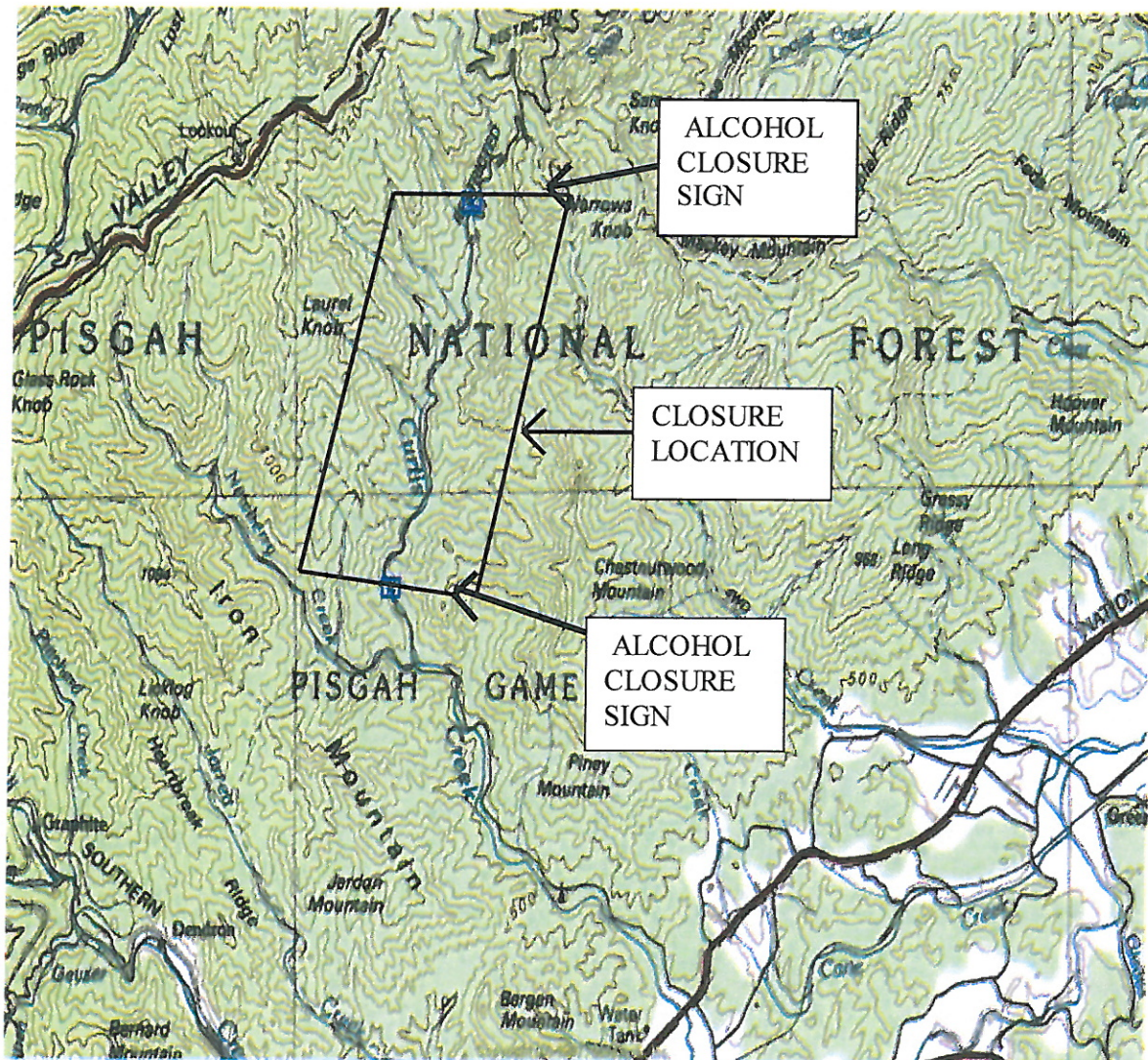
