





Great American Outdoors Act Overview

Bipartisan Legislation Passed by both the Senate and House and Signed into Law.

Two components:

Land and Water Conservation Fund (LWCF)

Public Parks and Public Lands Legacy Restoration Fund (LRF)

Definitions

Parks and Public Land Legacy Restoration Fund (LRF)

- ➤ Up to \$285M annually for Forest Service, FY 2021 2025
- At least 65% for non-transportation assets; recreation sites, visitor centers, dams, buildings, water and wastewater systems, communications, towers, trails and trail bridges
- ➤ Project investments aim to improve and increase public access by restoring and repairing non-transportation and transportation assets reducing deferred maintenance (DM).
- ➤ GAOA funding will help reduce DM backlog but does not resolve the full need.
- ➤ GAOA projects are funded under the USFS National Asset Management Program (NAMP)

2021 Funded Projects Undergoing Implementation

- The Northern Region received over \$29 million for 83 projects
 - ➤ 54 are in MT, 21 are in ID, 8 are in the Dakotas
- Funded FY21 projects in the Northern Region can be found here.

2022 Proposed Projects

- The Northern Region is proposed to receive approximately \$26.1 million of GAOA LRF funds over 74 projects
 - ➤ 55 are in MT, 3 in MT/ID, 12 in ID and 4 are in the Dakotas
- - ➤ Subject to Congressional Approval



2023 Project Proposals

- The Northern Region hosted 3 Information Sharing Sessions in June 2021 to inform the public about GAOA efforts.
 - ➤ Written comments were received from the public during project development, and via online comment period.
 - ➤ Montana GAOA Public Information Session Video | June 2021
- >FY23 recommended project list to be completed in November
- ➤ The Northern Region anticipates continuation of approved FY21 and FY22 proposed projects (ie: subsequent phases) to be funded in FY23-FY25, which will impact available funding for new FY23 GAOA LRF project starts.


