Southern Arizona Resource Advisory Committee Announces Final Selection for Secure Rural Schools Funding

Tucson, **AZ**, **November 24**, **2021**— The Southern Arizona Resource Advisory Committee (SA-RAC) announces selection of projects for funding under the authority of Title II Special Projects of the Secure Rural Schools and Community Self Determination Act of 2000.

A total of 23 proposals were submitted across Maricopa, Pinal, Pima, Cochise and Santa Cruz Counties for available Secure Rural Schools appropriated funds from 2017 - 2020. Over \$1.9 million of projects from Forest personnel, non-profit organizations, and private entities were submitted while only \$881,880 was available and all of the funding was applied towards projects.

The Resource Advisory Committee recommended a diverse suite of projects to improve ecosystem health, restore watershed conditions, and enhance wildlife habitat. These projects will promote community engagement, partnerships, and collaboration both on National Forest System lands and on non-federal land.
