In a Nutshell

A Forest Plan is written according to guidelines from the National Environmental Policy Act. The Environmental Impact Statement Analyzes alternatives for the Forest Plan. The Forest Plan is strategic in nature, it does not include site-specific project and activity decisions but provides the basis for future site-specific and project-level decisions.

Planning process began before the 2012 rule (Section 219.17 (b)(3)). The rule allows for the plan to be completed under the 1982 rule; however, the plan uses the objection process allowed under Section 219.17 (b)(3) and 219.52(a) and the monitoring requirement allowed under Section 219.12 (c)(1) in the 2012 Planning Rule.

Definitions

National Environmental Policy Act:

- The National Environmental Policy Act (NEPA) requires federal agencies to integrate
 environmental values into decision making processes by considering the environmental
 impacts of proposed actions and reasonable alternatives to those actions in
 cooperation with State and local governments, and other concerned public and private
 organizations.
- The NEPA requires agencies to use all practicable means and measures, including financial and technical assistance, in a manner calculated to foster and promote the general welfare, to create and maintain conditions under which man and nature can exist in productive harmony, and fulfill the social, economic, and other requirements of present and future generations of Americans.

Environmental Impact Statement:

- An Environmental Impact Statement, or EIS, is a document that describes the impacts on the
 environment as a result of a proposed action. It also describes impacts of alternatives as well as
 plans to mitigate the impacts.
- The EIS process requires scoping and public involvement. The substantive concerns voiced by citizens, public and private organizations, and other agencies must be addressed during the decision making process.

Record of Decision (ROD):

- · Public decision document that states what the decision is
- provides rationale behind the decision
- identifies the alternatives considered, including the environmentally preferred alternative;
- discusses mitigation plans, including any enforcement and monitoring commitments.

Management Areas:

- Spatially distinct areas where general management intent is similar
- Management area designation, name and acreage for each forest can be found in Table 11 on page 75 of the Revised Forest Land Management Plan.

Suitable Uses:

- Describes the appropriateness of applying certain resource management practices (uses) to a particular area of land
- General suitability matrix for management areas can be found in Table 25 on page 97 of the Revised Land Management Plan

Objectives:

 Projections of Forest Service activities and program outcomes that are measurable and time specific

Monitoring Framework:

- Designed to assess whether or not forest plan implementation is making progress toward achieving desired conditions. Implements specific monitoring requirements from regulation.
- Implementation: determines if we did what we said we would do
- Effectiveness: determines how well a particular practice helps achieve a project objective
- Validation: test key assumptions and generally involves design research
- Table 29 on page 110 of the Proposed Revised Land Management Plan displays the monitoring framework.

Design Criteria

Standards and Guidelines:

- Standards: Constraints placed upon project and activity decision making that are required to be met
- Guidelines: provide design specifications for projects and activities to ensure they are compatible with desired conditions and goals
