




Recreation fees are an investment in outdoor recreation. Current and future generations will benefit as 95% of the funds are reinvested in the facilities and services that visitors enjoy, use, and value.

Accomplishments Provided with Recreation Fees:

- Partnered with the Bob Marshall Wilderness Foundation to complete 400 miles of trail clearing. This accomplishment required 40-50 trips and involved young people and adults.
- Coordinated with the Collaborative Landscape Restoration Program and hired a four-person trail crew who completed trail maintenance and reconstruction projects on Swan Lake District.
- Worked with outfitters and guides to teach Leave no Trace principles to hundreds of backcountry visitors.
- Mentored volunteers on traditional trail skills and methods.
- Educated river users on correct disposal of human waste.
- Contacted more than 10,000 visitors during summer season.
- Performed security patrols and removed garbage along 200 miles of Wild and Scenic River corridor.
- Supported snowmobile trail stewards for four months who distributed maps, and offered safety tips and avalanche advisories to thousands of riders on 177 miles of groomed snowmobile trails and over 10,000 acres of recreation areas.



Additional Flathead Accomplishments

- Developed a group fire pit at Swan Guard Station.
- · Repaired windows at Mission Lookout.
- Completed maintenance and cleaning tasks, removed hazard trees, conducted security patrols, removed snow and provided firewood and safe drinking water at 14 recreation rental cabins.
- Supported hosts at Spotted Bear's popular campground.
- Repaired safety fence above the Southfork of the Flathead River.
- Removed hazard trees and monitored tree health throughout campgrounds.
- Painted facilities on routine schedule.
- Patrolled campgrounds to provide security.



The forest partnered with Glacier National Park to provide resource protection and visitor safety.


