EMERGENCY ORDER for FIRE

KENAI PENINSULA

Glacier & Seward Districts

Pursuant to Title 36 Code of Federal Regulations 261.50 (a) and (b), the following restrictions are in effect on all lands administered by the Chugach National Forest on the Seward and Glacier Ranger Districts. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and become effective when signed and will remain in effect until rescinded.

36 CFR 261.52 – Fire

- A. For the purpose of this order, building, maintaining, attending or using a fire, campfire, stove or charcoal fire is prohibited, EXCEPT in a developed camp grounds or picnic areas with Forest Service provided steel fire rings and or grates. The following actions are permitted: petroleum-fueled stoves, lanterns, or heating devices providing such devices meet the fire underwriter's specifications for safety. [Title 36, 261.52(a)]
- B. Smoking, except within an enclosed vehicle or building, a developed campground, or any other recreation site, or while stopped in an area at least three feet in diameter, which is barren or cleared of all flammable material. [Title 36, 261.52(d)]
- C. No operation welding, acetylene, or other torch with an open flame. [Title 36, 261.52(i)]
- D. No operation or using any internal or external combustion engine without a spark arresting device properly installed, maintained and in effective working order. [Title 36, 261.52(j)]

Exceptions:

Pursuant to Title 36 CFR 261.50 (e) the following are exempt from this order:

1. Any person with a permit authorizing the otherwise prohibited act or omission.
2. Resident owners and leasers of land within the restricted area are exempt from the above restriction, provided such fires are within the residence.
3. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.
4. Any Federal, State, or local law enforcement officer in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Penalty:

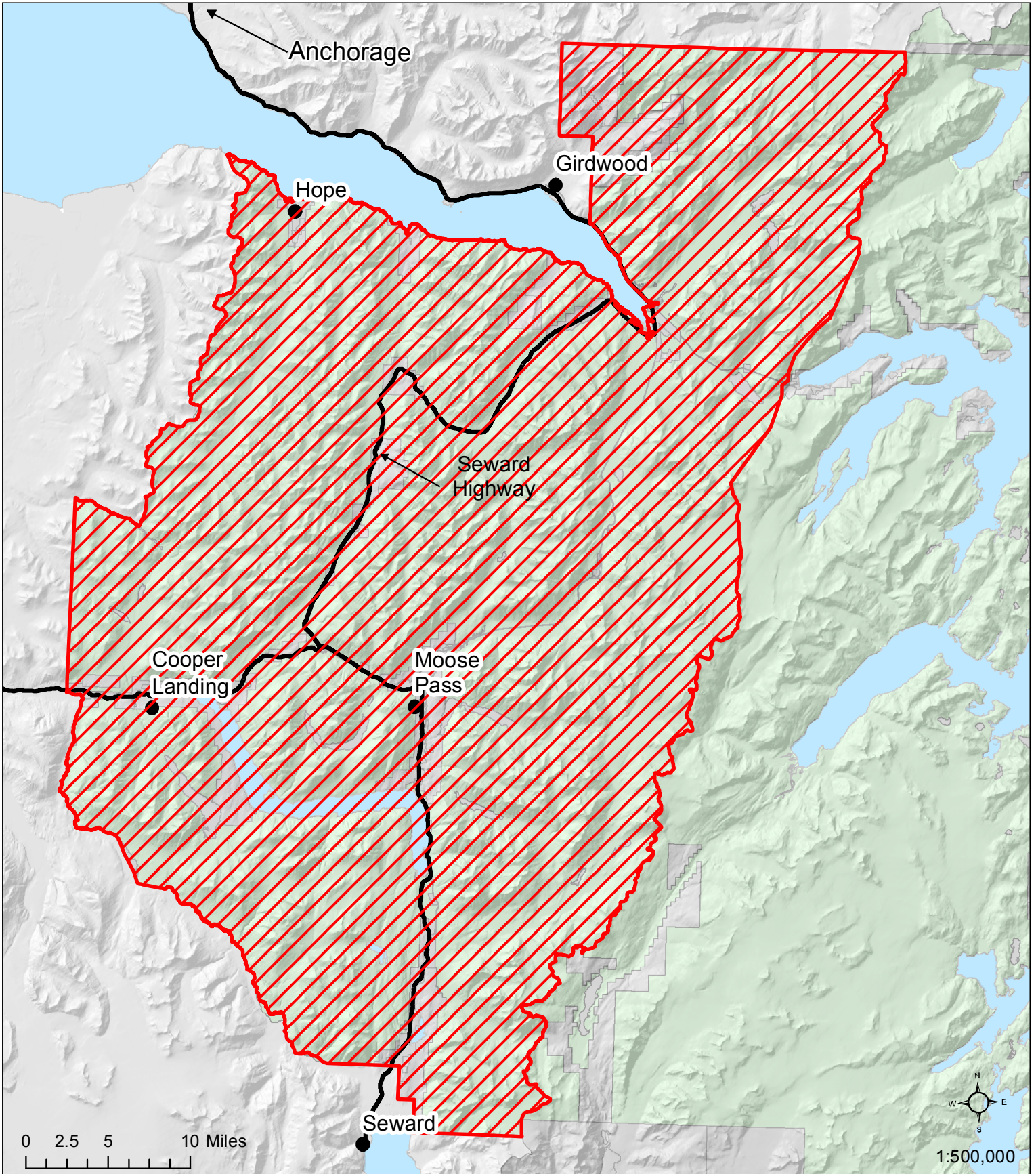
