

ORDER
USE OF MOTORIZED VEHICLES
ARAPAHO NATIONAL FOREST (ADMINISTERED BY WHITE RIVER NATIONAL FOREST)

Pursuant to 36 CFR, Section 261.50(a) and (b), the following acts are prohibited within the area generally known as Spring Creek (as shown on Exhibit A of this Order) within the Arapaho National Forest, until further notice.

- (1) Possessing or using a vehicle off Forest Development Roads.
EXCEPT: Snowmobiles operating on snow.
36 CFR 261.56.
- (2) Using any motorized vehicle on the Forest Development Roads listed in Exhibit B of this Order. EXCEPT: Snowmobiles operating on snow.
36 CFR 261.54(a)

Pursuant to 36 CFR, Section 261.50(e), the following persons are exempt from this order:

- (1) Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- (2) Any Federal, State, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
