# **Horn Creek Trail**





This scenic 5.7-mile biking and hiking trail is located in the southeastern portion of the Long Cane Ranger District and features four access points.

Many visitors begin their trip at Lick Fork Lake Recreation Area, which offers camping, picnicking, swimming, fishing and boating. Alternate access has been established on Forest Service (FS) Road 640 year round for those not wishing to enter the recreation area. Additional winter parking (December 16 - March 31) has been made available on Forest Service Road 634. Parking at either alternate access points does not require a fee.

**Directions:** From the square in downtown Edgefield, travel on Hwy. 23 south for 8.3 miles. Bear left onto Hwy. 230 and travel 0.4 miles. Turn left onto Lick Fork Lake Road (S 19-263) and travel 1.9 miles. Turn right into entrance.

Length: 5.7 miles

Surface type: Natural, packed clay

Trail blaze: White reflective

**Requirement:** A special permit is required for

organized or commercial rides.

**Safety:** Avoid trail use during the first two weeks of rifle deer season. Wear blaze orange the entire hunting season. Be mindful of traffic when traveling on or crossing roads.

**Season:** Trail open year round. Access from Lick Fork Lake available April 1 - Dec. 15. Winter parking available Dec. 15 - March 31 on Forest Service (FS) Road 634.
