





# Fire Restrictions

**ANGELES National Forest -** Dry summers, steep slopes and dense vegetation make wildfires a constant threat to National Forests, especially during the hot summer months. Wildfires destroy trees and hillside vegetation, endangers lives and property, and damage vital watersheds. Your help is needed to preserve these valuable lands from the ravages of wildfire. Please help protect the forest by checking with your local Forest Service office for current regulations and by observing these fire-safe measures during your visit.

#### **Fire Restrictions Are Now In Effect**

## Permit for stoves required

The only type of fire allowed outside designated Forest Service campgrounds and picnic areas at this time is a portable stove using gas, jellied petroleum or pressurized liquid fuel. A California Campfire Permit is required for your portable-stove use. Smoking is allowed only in buildings and vehicles, within developed recreation sites, or in areas that are cleared of flammable vegetation for a minimum of five feet. **Please use your ashtray!** 

# **Campfire Permits**

A California Campfire Permit is free and may be obtained at any Forest Service office. It is valid throughout the State California on National Forests, Bureau of Land Management lands and on certain state-protected lands. It does not give authorization for use of fire on any privately owned lands. Campfire permits are not required at developed Forest Service campgrounds or picnic areas accessible to the public by motor vehicle. Visitors may use Forest Service provided stoves, fire pits and campfire circles or their own liquid- or gas-fuel portable stoves. Wood and charcoal fires are allowed but must be contained in stoves. **Visitor-built "rock ring" campfires are not allowed.** 

## Remember to observe these fire safety measures year-round!

California Campfire Permits are required for fire use outside designated Forest Service campgrounds and picnic areas, and for *any* fire use at all trail camps. Possession of all types of fireworks is strictly prohibited! Target shooting is allowed only in designated shooting areas. Use of tracer and incendiary ammunition is prohibited. Off-Highway Vehicles may be used only in designated OHV areas and along designated routes. Approved spark arresters are required. "Street" vehicles must stay on roads only. Wood and charcoal fires are allowed at designated Forest Service campgrounds and picnic areas, but must be contained within stoves.
