



## Angeles National Forest Off Highway Vehicles

**The Angeles National Forest covers 668,000 acres within Los Angeles County, and provides many opportunities for Off Highway Vehicle (OHV) use.**

The Forest provides three major Off Highway Vehicle Staging Areas which offer the only OPEN riding opportunities. The rest of the Forest has a system of OHV DESIGNATED ROUTES which are the **only** roads and trails open to use by 4 wheel drive vehicles, ATV's or motorcycles. The routes are identified by "Designated Route" signs. All OHV support vehicles parked in the National Forest, along roads or in all but the San Gabriel OHV Area, must display an Adventure Pass. Enjoy your visit, and remember to **"Tread lightly"!**

### **RECOMMENDED AREAS:**

**Rowher Flat, Santa Clara/Mojave Rivers Ranger District** - About 47 miles of marked trails in a 10,000- acre OHV area. Some trails are impassable due to poor condition. Trails require intermediate to advanced riding skills. Novices should stay on the flat areas. An Adventure Pass is not required for green or red sticker vehicles, but is needed for other vehicles parked in the OHV area. Overnight camping is allowed, although there are no developed camping facilities. Toilets are provided, but no water is available. From Highway 14, take Sierra Highway off ramp (north); turn left on Rush Canyon Road.

**Littlerock Reservoir - Santa Clara/Mojave Rivers Ranger District** - Open from sunrise to sunset. At the present time, there is a closure of a large portion of the Littlerock Recreation Area and no OHV is currently available, as the lake is full. Check with the Santa Clara/Mojave River Ranger District Office for more information. OHV Open Area is sandy, rocky, flat, dry reservoir land. An Adventure Pass is required for vehicles parked in the Recreation Area. This is also a popular fishing location, and picnic areas are provided. No overnight camping is allowed. Take Highway 138 to Cheseboro Road. Turn south, 2 1/2 miles to entrance station.

**Drinkwater Flat - Santa Clara/Mojave Rivers Ranger District** - Closed until further notice.

**San Gabriel Canyon - San Gabriel River Ranger District** - 150 acres of rocky, sandy reservoir land. Stream flow year-round. Open Saturdays, Sundays and holidays 8 a.m. to 4 p.m. Fees: \$8 per primary vehicle, \$5 per secondary vehicle. Crowded on weekends. Toilets are provided, although there is no water. From the 210 Freeway, take the Azusa Ave., Highway 39 exit. Go north about 12 miles to Staging Area. Call (626) 9101235 or (626) 3351251 for information.

**A FEW REMINDERS:** Spark arrestors are required on all motorcycles, ATVs and Odysseys. Approved muffler systems are required on all four-wheel drive vehicles. All vehicles must be registered, and have green or red stickers (seasonally) for off highway vehicles; regular State Registration is required for street legal vehicles. Proper protective gear can make your ride safer and more enjoyable. Please wear a helmet, boots, gloves and eye protection. State law requires that all ATV riders must wear a helmet, and riders under age 18 must have completed an ATV safety course. **ALWAYS CHECK WITH YOUR LOCAL OFFICE FOR CONDITIONS AND RESTRICTIONS BEFORE YOU RIDE!**
