Recreation Program Fee Accomplishment Report 2009











Recreation fees are an investment in outdoor recreation. Current and future generations will benefit as 95% of the funds are reinvested locally in the facilities and services that visitors enjoy, use and value.

Accomplishments provided with recreation fees on the Clearwater National Forest:

- Funded seasonal employees and campground hosts who maintained campgrounds, cabin and lookout rentals, and provided visitor assistance and information. Specific tasks included:
 - o Painted toilet buildings and stained picnic tables.
 - o Purchased and installed new accessible fire rings.
 - Removed hazardous trees and chipped debris in developed campsites.
- Funded a River Ranger and additional employees who began to inventory and survey sites along the Wild and Scenic Lochsa River and presented river interpretive programs.
- Completed maintenance tasks on trails used by outfitters and guides and monitored outfitter and guide activities in these areas.
- Supported forest volunteers, seven Idaho Youth
 Conservation Crew members and several campground
 hosts, who spent a total of 6,800 hours maintaining
 developed sites, trails and providing visitors with forest
 information, interpretative materials, and answered
 questions.
- Lolo Pass Winter Recreation Area:
 - Groomed cross country ski trails throughout the winter season.
 - Funded employees to conduct avalanche monitoring and patrol snowmobile trails.
 - Installed bamboo poles to mark the snowshoe trail and new informational and site signs.
 - Installed information and site signs
 - Partnered with State of Montana Highway
 Department in order to provide plowed winter sports parking areas.

Special Feature

Weekend campfire programs were an added attraction at sites across the forest during the summer of 2009. In 2009, REA funds supported a partnership with the Palouse-Clearwater Environmental Institute. They provided an Americorps volunteer who was trained in environmental and conservation education. This volunteer then developed and delivered interpretive programs on a wide variety of outdoor education topics to forest visitors, including a Raptor Program that was attended by over 75 people.
